

OFFICIAL COUNTY COMMISSIONER PROCEEDINGS JANUARY 16, 1991

The Marbleton Landfill was discussed and the need to meet with the Teton County Commissioners was expressed. A meeting will be scheduled.

Loren Smith, State Hydrologist, scheduled interviews for the February 5th meeting for the purpose of hiring a new water commissioner.

Sandy Brewer, Director of the Sublette Hi-County Senior Citizens, Inc., with Sonny Korfanta and Glenn Allen discussed the renovation of the new Senior Citizens Center. A Community Services Block Grant will be pursued to fund the project.

Laure Latta, Director of the Pinedale Area Chamber of Commerce, invited the Board to attend the January 28th Chamber meeting at the Stockmans.

In accordance with the public notice published in the Pinedale Roundup on September 20, 27, and October 4, 1990, a public hearing was held for the establishment of a private road through the NW $\frac{1}{4}$ NE $\frac{1}{4}$ , Section 21, T36N, R114W, Sublette County, Wyoming, by Leo Everett Benson and Rosemary Benson, owners of property in the S $\frac{1}{2}$ NE $\frac{1}{4}$ , Section 21, T36N, R114W, Sublette County, Wyoming. David Clauss, attorney for the Bensons, presented the petition and notice and explained that the Benson's have been unable to obtain access to their property from J. Scott Miller and Renee M. Miller. Benson has access from the Forest Service and requests a 30 foot access from the Millers. After discussion, John Mackey, attorney for the Millers, stated that his clients would probably grant the access within 30 days. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to accept the petition and appoint viewers to view the road after 30 days to allow time for possible settlement. The motion carried.

John Healing of Exxon discussed the current tax abatements his company has acquired from the State Board of Equalization.

In accordance with the public notice published in the Pinedale Roundup on December 27, 1990, public hearing was held for the following items:

1. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to accept and act upon the recommendation of the Planning and Zoning Commission. Upon vote, the motion carried, and the following resolution was adopted:

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION BY NATALIE SMITH TRAYLOR CARLSON, MICHAEL J. ECKERT AGENT, TO RECLASSIFY AND REZONE 17.97 ACRES FROM A-1 DISTRICT TO R-R 5 DISTRICT, BEING PART OF THE S $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ , SECTION 3, T33N, R109W.

2. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to approve the conditional use permit application by Michael J. Eckert to operate a bed and breakfast business on the Smith property being a part of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ , Section 3, T33N, R109W. The motion carried.

Misty Haehn, Zoning Administrator, reported that the well at the Daniel Fire Hall is estimated to be 200 to 250 feet deep.

Arlan Hiner, Area Manager for the BLM, presented the Big Piney LaBarge Coordinated Activity Plan to the Board. An open house will be conducted from noon to 5 p.m. on January 24th at the Marbleton Fire Hall with a public hearing on the Activity Plan scheduled for 7 p.m. that same evening. Comments on the plan will be accepted until February 15, 1991. The Board requested a new gravel pit near State Highway 351.

Dr. Bob McElhose, Director of Sublette Community Counseling with Board Members and employees, discussed current financial difficulties. Board Chairman Bob Eldan requested emergency funding of \$25,000. The Board denied the request and encouraged the Counseling Service to submit a request to be heard during the budget process in the spring.

Darrell Walker and Jack Doyle, Members of the Sublette County Soil Conservation District, presented their Annual Plan of Work and informed the Board of increased educational efforts and the possibility of a future funding request.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to appoint the following individuals to the respective boards:

Pinedale Airport Board: Val Pierson  
Sublette County Weed & Pest Board: Robert Beard and Kenneth Shriver

The Board signed the agreement between the Town of Pinedale, School District #1, and the Forest Service for the snow removal on Skyline Drive.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to issue a malt beverage permit to the Pinedale Snow Explorers for February 9, 1991, at Sage Brush Downs for the Pinedale 100. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to adopt Resolution No. 91-288C approving the establishment and election of Sublette County Mosquito Abatement District No. 2. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to adopt Resolution No. 91-289C approving the establishment and election of Sublette County Mosquito Abatement District No. 3. The motion carried.
