OFFICIAL COUNTY COMMISSIONER PROCEEDINGS MARCH 5, 1991

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Craig Crandall, Monte Skinner, Buzz Wassenberg, Dave Arambel of the Pinedael Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of February 19, 1991, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Wassenberg. The motion carried.

The official bond for Bonnie Krininger, Landfill Operator, in the amount of \$1,000, was approved and ordered filed with the County Clerk.

Larry Konetzki, Resident Engineer for the Wyoming Highway Department, Presented the McLoughlin Pit haul road agreement for signature. The Board approved the agreement and signed it.

It was moved by commissioner Wassenberg and seconded by Commissioner Skinner to expand the Golf Committee to six members and appoint Mike Stiewig and Gil Winters to the Committee. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to issue a beer permit to the Pinedale Boat Club for the fishing Derby at Fremont Lake on March 2 and 3, 1991, and the issue a beer permit to the Daniel Homemakers for the Chili Cookoff on March 23, 1991, at the Daniel Schoolhouse. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to designate the Key Bank of Wyoming, Jackson-Big Piney Branch as a depository for public funds.

Bob Johnson, Water Commissioner, informed the Board that the legislature had made all water commissioners state employees as of July 1, 1992, if funding is available in the 1992 legislature.

Rod Bennett discussed his delinquent taxes. The Board advised him to consult this legal counsel and keep in contact with John Crow, County Attorney.

Mark Jones, Doc Jensen, Renee Jones, Paul Scherbel, and Misty Haehn, discussed the Big Sandy-Elkhorn Road and its easements. It was decided to obtain costs of relocation of the road at the Jones' property. The Board will view the road and determine a solution at a later date.

Permits for utility lines within a County right of way were granted to Telephone Utilities of Wyoming on County Road Nos. 23-144 and 23-139.

Plats were signed for the Daniel-Merna County Road No. 23-112 and Reardon Draw County Road No. 23-139.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to adopt Resolution No. 91-293C establishing the Daniel-Merna County Road No. 23-112. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to adopt Resolution No. 91-293C establishing the Siems County Road No. 23-163. The motion carried.

Paul Scherbel presented a grant application from the Big Piney Airport Board for signature. The Board signed the application.

Paul Scherbel and Miriam Carlson, Mayors of Big Piney and Pinedale, respectively, discussed their dog management programs. The Game and Fish and Sheriff Cain will be contacted for more information.

Mark Noble, Bethany Walker, and Dave Sebesta, of the Pinedale Snow Explorers discussed the County's snowmobile registration funds. It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to give the County's registration fee to both County snowmobile clubs, once that a written request is submitted. The motion carried.

Bubba Larson discussed his sewer situation with the Board. The Board advised Larson to submit an acceptable site plan so that the Zoning Administrator can issue a sewer permit.

John Mackey advised the Board that an easement had been sent to David Clauss concerning the Leo Benson private easement. The Board delayed adopting the resolution establishing the private road.

Jim Latta, Western Farm Bureau agent, discussed the County's liability insurance and presented quotes from his company. The Board took no action on the presentation.

Adrienne Peterson, Ken Shriver, Mike McGinnis, of the Weed & Pest District and Road & Bridge Department, discussed the construction of a building on the County's property near Marbleton to be jointly used by Weed & Pest and Road & Bridge. The bids for the building will be opened on March 19, 1991, at 1 p.m. It was suggested that an occupancy agreement be prepared after the building is constructed.

Dale Hill and Tim Singewald, of the Pinedale Area Chamber of Commerce, informed the Board of their possible application for funds for a new Chamber building. Hill and Singewald requested the location of the present Chamber hut for the new building. The Board informed them that the location was unavailable due to deed restrictions.

Shrimp Woffinden complimented the Road & Bridge Department on the condition of the roads in southern Sublette County.

A letter of resignation was received from Chuck Arbogast. The Board accepted the resignation effective March 29, 1991.
