OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS MARCH 19, 1991

The Board of County Commissioners met in regular session on this date at 9 a.m. with Craig Crandall, Monte Skinner, Buzz Wassenberg, Dave Arambel of the Pinedale Roundup, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of March 5, 1991 were approved and ordered filed on motion by Commissioner Wassenberg and seconded by Commissioner Skinner. The motion carried.

Dana Stone, District Forester, presented the 1991 Wildland Fire Control Annual Operating Plan, which was accepted by the Board. Stone was referred to Mike McGinnis concerning his request for gravel on the road to Irish Canyon. Stone informed the Board of his desire to start another living snow fence project in the County and requested recommendations for a location.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to accept and sign the letter of engagement from Mortenson, Stevens, and Company. The motion carried and the letter was signed.

Sheriff Jack Cain discussed his budget shortage with the Board. The Board requested a projection of expenses for the remainder of the fiscal year by March 29th. Information concerning dogs was presented and referred to Mayor Scherbel in Big Piney. The Board decided to defer any action to the Towns.

Dale Hill of the Pinedale Area Chamber of Commerce, requested the Board provide an award for the Rendezvous Parade. The Board requested more information.

Burleigh Binning informed the Board that he is considering construction of a mobile car crusher and would be interested in contracting with the County to crush and remove cars at the landfills.

Diane Oglietti, Director of the Pinedale Preschool, presented copies of the early childhood survey and informed the Board of the Preschool's activities.

Ed Wood, counsel for Rod Bennett, presented a lease agreement for the County and Bennett. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to accept the agreement. The motion carried.

John Mackey, counsel for J. Scott Miller and Renee M. Miller, presented objections and an order and motion for dismissal of proceedings regarding the Benson petition for a private easement. The Board directed the County Clerk to contact C. David Clauss, legal counsel for Bensons, and provide him with a copy of the objections. The Board tabled any action on the petition and motion for dismissal.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to engage Farm Bureau Insurance for the County's liability insurance effective April 1, 1991, and cancel the County's participation in the Local Government Self Insurance Program provided by the State of Wyoming. The motion carried.

The Board signed the contracts for the chip seal projects for the roads previously designated for this year.
