

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS MAY 28, 1991
MAY 28, 1991

Darrell Walker, Jack Doyle, and Caroline Brazell representing the Soil Conservation District, requested \$21,362 for FY92 to provide various soil conservation programs to the public. The Board denied funding the request and encouraged the District to pursue secure funding by mill levy again.

Tentative approval was given to the following budgets and amounts:

Library Board	\$200,000
Justice Court-Cramer	45,550
Rural Health Care District	2 mills
Fire Board	1 mill

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to advertise for an architect to pursue the best solution to provide handicapped accessibility to the District Court. The motion carried and the County Clerk was directed to make the advertisement.

Alex Heil and Sue Kramer discussed forming a committee to pursue recycling in Sublette County. The Board encouraged the formation and Commissioner Skinner volunteered to serve on the committee.

Sandy Brewer, Director of Sublette Hi-County Senior Citizens, Inc., presented their budget request of \$19,034.08. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to table the request until request is made for the building renovation and the \$2,540.40 requested for the Adult Home Care program was denied, and referred to the State of Wyoming. The motion carried.

Amy Reed, Sandy Goltz, and Henry Schmidt, representing the Wind River Youth Center, discussed their program progress with the Board and requested the possibility of requesting funding for facilities. The Board was informed that the Governor's Committee will be meeting in Pinedale on July 17 and 18.

In accordance with the public notice published in the Pinedale Roundup on May 2, 9, 16, and 23, 1991, a public hearing was held for the renewal of County Retail Liquor Licenses, Restaurant Liquor Licenses, and Retail Malt Beverage Permits.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to approve the renewal application for Retail Liquor Licenses for the Green River Bar, Boulder Liquors, Elkhorn Bar, and The Place. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to approve the renewal applications for Restaurant Liquor Licenses for Lakeside Lodge and Fort William Recreation Area and table the application from Ponderosa Lodge. The motion carried. The Ponderosa Lodge application was referred to John Crow, County Attorney, due to a letter received from the Department of Revenue and Taxation concerning the requisite \$250 in sales from the Liquor Commission.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to approve the renewal applications for Retail Malt Beverage Permits for Hoback Village, Elk Ridge Lodge, Inc., DC Bar Guest Ranch, and Dane's Chevron Country Store, and table the applications from Boulder Lake Lodge, Inc. and Triangle F Lodge. The motion carried. The Boulder Lake Lodge, Inc. application was referred to John Crow to determine the appropriate applicant and procedure. The Triangle F Lodge application was referred to John Crow to obtain the stipulation of their lease authorizing the sale and dispensing of malt beverages in the described room.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to approve the renewal application for a Special Club License for the Pinedale Golf Club, Inc. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to reconvene the County Board of Equalization to hear a protest from Katherine Dunning concerning a 22% increase in the assessed valuation of her property. The motion carried. Dunning presented her protest. Janet Montgomery, County Assessor, informed the Board and Dunning that the State is scheduled to provide training on assessment on selected properties and that the Dunning property could be reassessed at that time. Dunning agreed to the State reassessment and review. The Board tabled any action until the State review is completed.

The County Board of Equalization heard a protest from Katherine Dunning representing Ron and Barbara Brown. Dunning informed the Board that the assessment of Brown's property had increased double. After discussion of the various values, it was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to reduce the increase to 25%. The motion carried. Later in the meeting, Montgomery presented a copy of the Brown 1990 Tax Notice which was paid on December 31, 1990, at the same assessment as 1991. Based on this information, it was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to rescind its previous motion and let the assessment stand. The motion carried. The County Clerk was directed to notify the Browns.

Gerald Mason questioned two of his assessment schedules and was referred to the County Assessor for review. The Board tabled any action until the County Assessor completed her review.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to recess the County Board of Equalization and reconvene the Board of County Commissioners meeting.

John Frullo, Architect for the Daniel Fire Hall, presented bids from Custom Construction and Rick & Rich to make necessary repairs to the building to meet fire code. Frullo assured the Board that he would inspect the work and compliance with the fire code. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to award the bid to Rick & Rich and divide the cost of \$2,500 with Frullo. The motion carried.

Jim Latta, Farm Bureau agent, inquired about insurance coverage at the Golf Course. It was decided to provide coverage for the cart building and shop.

There being no further business, the meeting was adjourned.
