Henry Ruland, Henry Schmidt, and Bob Hanson. Sheriff Cain agreed to loan Henry Ruland to the County Attorney for investigation, creating another slot for a deputy in Cain's reorganization plan. It was indicated that Don Schooley would be moved from the Pinedale Metro to the County and that Roland Smith would be moved to the Pinedale Metro. The County Law Enforcement budget was tentatively approved at \$359,453.

The County Clerk was directed to audit any holiday time earned by County deputies which has not been paid.

In response to a letter from Francis Petera, Director of the Wyoming Game and Fish Department, the Board signed a letter concerning the lack of participation in the maintenance of the road by the Game and Fish. A copy of the letter was provided to the Pinedale Roundup.


It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to extend the hours of operation for County liquor licenses on Sunday, June 30, 1991, for the Bondurant Barbecue. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to issue a malt beverage permit to the Sublette County Historical Society for July 14, 1991, for the Rendezvous. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to renew the malt beverage permit for Boulder Lake Lodge. The motion carried.

There being no further business, the meeting was adjourned.

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
JULY 2, 1991

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Craig Crandall, Monte Skinner, Buzz Wassenberg, Dave Arambel of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of June 18, 1991, were approved and ordered filed on motion by Commissioner Wassenberg and seconded by Commissioner Skinner. The motion carried.

The official bonds for Paul Scherbel, Secretary/Treasurer for the Joint Big Piney/Marbleton Volunteer Fire Department Board, in the amount of \$20,000; and Rex Poulsen, Treasurer for the Sublette County Library Board, in the amount of \$4,000, were approved and ordered filed with the County Treasurer.

Ralph Cole, Civil Defense Director, discussed the process of providing a replacement for his position with the Board. The County Clerk was directed to start the advertisement for this position.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to adopt Resolution No. 91-309C authorizing the transfer of \$74,457 from the General Fund and \$52,000 from General Accounts, Elementary School for a total of \$126,457 in the following amounts: \$5,400 to Detention & Communications; \$52,000 to Courthouse & Jail, Insurance; \$30,000 to General Accounts-FICA, Insurance, & Retirement; \$4,500 to General Accounts-Workers Compensation; \$500 to Skyline Drive Plowing; and \$34,057 to General Accounts-Clinic Addition. The motion carried.

Bernie Scott, Program Coordinator for the Wyoming Technology Transfer Center, informed the Board about his program and thanked them for their continued support.

In accordance with Resolution No. 91-307C, the Board held public hearing for the establishment of North Cottonwood County Road No. 23-129 by adverse possession. Protests were stated by Jim and Margie Thomas and Ed Wood, representing CK Land and Livestock Corporation, Inc. It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to table the procedure until information concerning County maintenance and construction could be obtained. The motion carried.

Gil Winters of the Sublette County Golf Committee, presented the Board a financial statement from Rendezvous Meadows Golf Course. Winters requested the use of a County truck to haul sand and road repair. The Board granted the requests.

Utility easements were granted to Utah Power & Light Company across Pinedale South County Road No. 23-123, in Sections 4 and 9, T33N, R109W, and Orcutt Drive County Road No. 23-189, in Section 34, T34N, R109W.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to waive the license fee of \$200 for temporary merchants in accordance with W.S. 33-20-203(b) for Rendezvous. The motion carried and the County Clerk was directed to notify the County Treasurer.

Janet Montgomery discussed developing another layer for the County employee pay plan. The Board indicated that it would accept recommendations from the Elected Officials.

The Board and County Clerk made the final review of the County budget.

The following people were appointed to the following boards for three (3) year terms:
