OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
JULY 16, 1991

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Craig Crandall, Monte Skinner, Buzz Wassenberg, Dave Arambel of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding regular meeting of July 2, 1991, were approved and ordered filed on motion by Commissioner Wassenberg and seconded by Commissioner Skinner. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to sign the budget resolution for FY92 approved the previous evening. The motion carried and the resolution was signed.

Arlan Hiner of the BLM, discussed the Soda Lake Road and indicated that a gravel pit has tentatively been located. Hiner was assured that the County is still willing to install the necessary culverts and spread gravel; however, scheduling the work is a problem, but will be attempted.
