OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
SEPTEMBER 3, 1991

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Craig Crandall, Monte Skinner, Buzz Wassenberg, Dave Arambel of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The official bonds for Eva C. Kallas, Director of Sexual Assault & Family Violence, in the amount of \$20,000; and Herman A. Genetti, Landfill Attendant, in the amount of \$1,000, were approved and ordered filed with the appropriate County official.

Mike McGinnis, Road & Bridge Superintendent, informed the Board that he had ordered culverts to repair the Boulder bridge, that chips are needed for the completion of the recycling project south of Boulder, and that the Calpet road will be stripped in 1992.

Dr. Charles Chidsey discussed the road agreement for the relocation of the County Road. The agreement will be prepared by the County Attorney. Paul Scherbel, Mike McGinnis, and Dr. Chidsey will meet within the next week to physically locate the new section.

Arlin Hiner, Ramsey Bentley, and Doyle Conklin of the BLM, informed the Board that the BLM has ordered 14 culverts for the Soda Lake Road. The County will try to get them installed this fall, but will do the installation next spring, if necessary. The purchase of the Pinedale Landfill was discussed and the Board was informed that a Land Transfer Audit will need to be performed. The Board
