

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
FEBRUARY 4, 1992

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Craig Crandall, Monte Skinner, Buzz Wassenberg, Dave Arambel of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding minutes of January 21, 1992, were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Wassenberg. The motion carried.

Sealed bids were opened for the construction of a recycling shed to be located at the Pinedale Landfill. Bids were received from Milt Schilling Construction, TAD, Inc., Craig Jensen, Reno Restorations, Prairie Creek Construction, Mitch Robertson & Wade Johnson, and BR Construction Company. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to award the bid to the lowest bidder, Craig Jensen at \$2,490. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to adopt Resolution No. 92-343C incorporating the alteration of Fremont Lake County Road No. 23-154 into the record of the county road. The motion carried.

After discussion with Tagg Guio, Chairman for the Big Piney Marbleton Airport Board, it was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to approve and sign the airport master plan. The motion carried and the plan was signed.

It was decided to arrange a meeting with the Teton County Commissioners to discuss recycling tires at the landfill.

Bob Reese, District Forest Ranger, discussed the designation process for wild and scenic rivers. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to send a letter to Brian Stout requesting an extension of the comment period. The motion carried.

Reese commented on White Pine and the Union Pass Road.

The County Elected Officials, Mary Lankford, Clerk; Nylla Kunard, Treasurer; Janet Montgomery, Assessor; Marilyn Jensen, Clerk of Court; and John Crow, Prosecuting and County Attorney, presented a written statement expressing their concern over the settlement of the Debbra Arter salary dispute and protesting the actions of Sheriff Jack Cain.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to accept the proposal and bid from Home Oxygen Plus Equipment for a lift to be installed in the Courthouse to provide access to the courtroom in the amount of \$34,400. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to adopt Resolution No. 92-344C declaring the Boulder Lake Improvement District organized. The motion carried.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to issue a beer permit to the Pinedale Boat Club for February 29 and March 1, 1992, for the ice fishing derby at Fremont Lake. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to issue a beer permit to the Pinedale Snow Explorers for February 8 and 9, 1992, for the Pinedale 100 snowmobile race at Fremont Lake. The motion carried.

The Board signed the contract with the State of Wyoming for the Preschool grant.

The Board renewed the gravel pit permit for the pit at the Big Piney Cemetery.

The purchase of a lap top computer was approved for John Crow.

At 1:00 p.m. the meeting was moved to the courtroom for the continuation of hearing on the issuance of a retail liquor license. Commissioner Wassenberg stated his opposition to issuing the license. It was moved by Commissioner Skinner and seconded by Chairman Crandall to issue the retail liquor license to Joe Retel of Country Lane Groceries and Gas. The motion carried with the vote being Crandall-aye, Skinner-aye, and Wassenberg-nay.
