

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
MAY 26, 1992

The Board of County Commissioners met as the County Board of Equalization on this date at 9:00 a.m. with Craig Crandall, Monte Skinner, Buzz Wassenberg, and Mary Lankford, County Clerk present.

Joe Hicks presented three informal protests to the Board. All protests were not filed in accordance with state statute, in a timely manner. Janet Montgomery, County Assessor, explained to the Board and Hicks that tracts of land less than forty acres were assessed as rural residential property by statute. Tracts located within the Town of Pinedale are also assessed as rural residential. All tracts protested were of this description. It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to deny any adjustment to protested assessment. The motion carried. In reviewing the map of the Pinedale area, Montgomery noticed two tracts of land located west of Pinedale which could be combined to make a greater than forty acre tract and informed Hicks she would make that adjustment. The Board encouraged Hicks to file a formal protest next year.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to recess the County Board of Equalization until June 8, 1992. The motion carried and the Board sat as the Board of County Commissioners.

Daphne Platts, County Librarian, presented the Library Board's FY93 budget request. Tentative approval was given of .9 mills.

Bob Looney inquired if the Board had a position concerning MRS.

Gerald Mason discussed the requirement of covering loads to the landfill to minimize litter along the highway.


Ron Saypol and Ed Wood presented a purchase agreement for the Daniel property. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to accept the offer, after review by John Crow, and to sell the Daniel property for \$70,000; with a \$20,000 down payment at closing on June 22, 1992, and the remaining \$50,000 to be paid to the County in annual payments of \$10,000 each year for five years due on December 1. The motion carried.

Laura Marincic's third grade class visited with the Board.

Mayor Miriam Carlson and Town Council members Dave Hohl and Rose Skinner discussed the metro contract for the Town of Pinedale. Concern was expressed about lack of funding.

There being no further business, the meeting was adjourned.

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
JUNE 2, 1992

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Craig Crandall, Monte Skinner, Buzz Wassenberg, John Crow, Paul Scherbel, Misty Haehn, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting were approved and ordered filed on motion by Commissioner Skinner and seconded by Commissioner Crandall. The motion carried.

The official bond for Paul Scherbel, Secretary/Treasurer for the Big Piney/Marbleton Volunteer Fire Department, in the amount of \$20,000, was approved and ordered filed with the County Treasurer.

Sealed bids were opened for the hauling of recyclables to Jackson. Bids were received from Eiden Construction, Lat Straley, Fred Freeman, and North Park Transportation. The bids were referred to Mike McGinnis for review and no action was taken at this time.

It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to adopt Resolution No. 92-355C accepting the Chidsey relocation of Paradise County Road No. 23-136. The motion carried.

Misty Haehn and Paul Scherbel discussed the remaining easements on North Cottonwood and were directed to pursue the Thomas easement.

Sheriff Jack Cain appeared before the Board in reference to attendance at the FBI Academy. Commissioner Skinner expressed his strong objection.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to sign the revised project agreement on the Calpet Road chip-seal project. The motion carried and the agreement was signed.

Commissioner Wassenberg reported on a meeting he attended concerning funding for road projects through the Wyoming Department of Transportation. Sublette County designated Daniel-Merna County Road No. 23-112 for the improvement project and it has been recommended to receive 1.7 to 1.9 million dollars. Final awards will occur at a later date.
