OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
DECEMBER 1, 1992

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Craig Crandall, Monte Skinner, Buzz Wassenberg, Stuart McKinley, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of November 17, 1992, were approved and ordered filed on motion by Commissioner Wassenberg and seconded by Commissioner Skinner. The motion carried.

Senator Bob LaLonde and Representative Budd Betts discussed issues of importance with the Board. Issues discussed were advertisement and bidding of county work, abandoned vehicles, scales, State Board of Equalization rules and regulations, and drilling and minerals information.

The following petitions and affidavits for abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Michael Sirkel, \$82.29; Lary Lozier, \$64.74; Mobil Oil, \$8,358.74; Mobil Oil, \$15.15; Carl A. Hafner, \$89.80; Mobil Oil, \$50.12; James H. and Roberta L. King, c/o Ken Hallinan, \$66.71; Hawk International, \$38.37; Enron Oil & Gas, \$243.44; Enron Oil & Gas, \$1.23; Paul Crittenden, \$380.61; Robert H. and Coleen F. Chase, c/o Zoel D. Blackmon, \$97.72.

The Board denied a petition and affidavit for abatement of taxes by Steve Kanski in the amount of \$76.78.

Paul Scherbel, Marleann Wise, and Misty Haehn discussed a donation of land by Crowell O. Dean for a geological and historical interpretive site. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to accept the donation of land. The motion carried.

Doyle Childs presented a revised petition for the alteration of the status of the roads in Hoback Ranches. It was moved by Commissioner Wassenberg and seconded by Commissioner Skinner to accept the petition at this time, as altered, and take the petition under advisement. The motion carried. John Crow will prepare the public notice for hearing.

The Board received a letter from Jackie Sea and Sam and Judy Martin regarding possible expansion of the Golf Course.

It was moved by Commissioner Skinner and seconded by Commissioner Wassenberg to adopt Resolution No. 92-372C establishing a policy regarding public records. The motion carried.

The Board signed a contract with Rocky Mountain Auditing Service for the review of oil and gas production and sales in determination of Sublette County's proper ad valorem tax assessments for production periods 1985 to present. The contract amount of \$10,000 will be recovered by Rocky Mountain and paid by Sublette County from monies collected as a result of reviews performed by Rocky Mountain.
