Bob Johnson, Civil Defense Coordinator, reported on his activities and application for Hazardous Material funding.

The Board approved a voucher submitted to refund \$18.94 to the CommunityService Block Grant program for the Pinedale Preschool to be paid from the General Fund.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to authorize County Clerk Mary Lankford to sign the statement of authorization for a safety deposit box for the Library Board and recommended their use of the County Clerk's vault for off-site storage. The motion carried.

Zoning Administration Misty Haehn reported on the recent Planning and Zoning Commission meeting and was directed by the Board to prepare a letter to the Commission regarding the County Landfill with the assistance of the County Clerk. Haehn also reported on the sludge disposal in Bondurant and informed the Board that the operation was DEQ approved and that EPA will be sending information to the Board.
