

Eric Peterson and Stella McKinstry informed the Board that the computer in their office is inoperable. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to approve a lease-purchase of a new computer to be purchased in July, after the new budget. The motion carried and the Board indicated that it would consider supplementing their budget at the end of the budget year.

Justice of the Peace Bill Cramer requested that the Board appoint alternate Justices of the Peace, due to required availability. Judge Cramer recommended that Ruth Neely and Bert Reinow be appointed as the alternates. The Board requested that a resolution be prepared for the purpose of appointing alternate Justices of the Peace.

County Clerk Mary Lankford reviewed the current budget and discussed the upcoming budget preparation.

In accordance with the public notice published in the Pinedale Roundup on December 24, 1993, public hearing was held for the following:

- 1. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to approve the variance application by Roy and Carolyn Fisk to allow 10 acres in A-1 district being the E½NE¼NW¼, Section 24, T38N, R114W, which is the current location of the Black Powder Trading Post in Bondurant. The motion carried.
- 2. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to approve the conditional use permit application by Sublette County for the existing 80 acres of landfill and an additional 80 acres adjoining the Marbleton Landfill, being part of Section 22, T30N, R111W. The motion carried and the Board approved and signed a letter to the Planning and Zoning Commission concerning the landfill.

Sherriff Jack Cain and Undersheriff Bob Hanson presented the December 1992 reports, discussed legislation, and discussed the overexpenditure of \$13,303.08 in deputies salaries. The Board informed Cain that they will be unable to supplement his budget, due to lack of additional revenues. Cain indicated that he was considering layoffs. The Board recommended curtailing spending to cover the deficit.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to pay the Davis, Donnell, Worrall and Bancroft, PC voucher in the amount of \$174.25 of November 1992, rejected by the Board, with the stipulation that all outside engagements of attorneys will be approved by the Board, Prior to engagement in the future by Cain. The motion carried.

Bob Johnson informed the Board that the Sublette County Local Emergency Planning Committee meeting has been scheduled for 2 p.m. on March 2, 1993, in the Commissioners Meeting Room. Mr. Gary Ayers from the Wyoming Emergency Management Agency will be present.

It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to endorse HB 203 amending W.S. 24-3-101, 110, and 118, so that a "public" road may be changed to a "private" designation. The motion carried and the endorsement was signed.

A public meeting was held to discuss the current status of the White Pine Ski Area. District Ranger Bob Reese presented a history and update on the area and permits. Reese requested that the Board make recommendations on whether or not the special use permits should be issued to Wind River Resorts, Inc. and whether or not to proceed with the disposal of the existing facilities at White Pine Ski Area. Approximately 35 people were in attendance, with the hearing being moved from the Commissioners Meeting Room to the Courtroom. Comments were made by Becky Miller, Steve Mackey, Sally Mackey, Peggy Weber, Randy Miller, Stuart Thompson, Laurie Hartwig, Kay Buston, Don Wright, Gary Wilson, Toby Gibson, and the members of the Board. The Board deferred making any recommendations until its next regular meeting, February 2nd.
