


OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
MARCH 2, 1993

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Monte Skinner, Buzz Wassenberg, Stuart McKinley, Mike McGinnis, Linda Fantin of the Pinedale Roundup, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of February 16, 1993, were approved and ordered filed on motion by Commissioner Wassenberg and seconded by Commissioner McKinley. The motion carried.

The proposed sale of Section 16, T33N, R109W, a State school section, was discussed. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to request a public hearing prior to the sale of the section. The motion carried.

Misty Haehn, Zoning Administrator, informed the Board that she is still unable to obtain three easements on the Little Sandy Elkhorn road. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to direct John Crow to send letters notifying the landowners that maintenance and plowing will cease on March 15th. The motion carried.

The Board discussed the renewal of the DEQ permit for the Pinedale Landfill. Engineering costs are estimated at \$20,000 for a permit for four years. The County has been unsuccessful in attempting to purchase the landfill site from the BLM. Chairman Skinner and Mike McGinnis have discussed locating a transfer station at the Town lagoon with the Pinedale Town Council. The Board directed McGinnis to investigate the costs of a transfer station and present the information to the Board at their next meeting on March 23rd.

The Board of Directors of the Sublette Hi-Country Senior Citizens Center discussed and reviewed the remodeling project and grant for the Mountain Meadow building. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to table the remodeling project and pursue remodeling, repairing, and enlarging their present location and return to the Board on March 23rd with recommendations. The motion carried.

Ronnie Audevart, Director of the Pinedale Preschool, reported on her agency's activities.

Dana Stone, State Forrester, presented the 1993 Fire Operating Plan. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to sign the Operating Plan. The motion carried. Stone also presented a Memorandum of Understanding for Federal Excess Personal Property. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to sign the memorandum. The motion carried.

Mike McGinnis, Road & Bridge Superintendent, presented his monthly reports.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to have the appropriate documents prepared to remove the reservation on the old clinic property in Big Piney presently held by the Town of Big Piney. The motion carried.

It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to approve the beer permit issued to the Pinedale Boat Club for the fishing derby held on February 27 and 28, 1993. The motion carried.
