No action was taken and Wilson will discuss the situation with her neighbors.

Mike McGinnis, Road & Bridge Superintendent, reported a landfill and road activities.

Sherriff Jack Cain, Undersherriff Bob Hanson, and John Crow dicsussed the contract for the lease-purchase of vehicles, budgets for the towns, and juvenile detention. The Board informed Cain that it would only allow \$75,000 for FY94 vehicles.

Janet Montgomery, County Assessor, presented materials to the Board regarding assessed valuation of minerals and oil.

The applications for the County Commissioners' Tuition Waiver Scholarships were reviewed. Two scholarships were awarded to Big Piney High School seniors Casey Rees and Cheryl Profit, with Gudrid Thayer alternate. One scholarship was awarded to Pinedale High School senior Michael E. Adams, with Sara Hegardt, firts alternate, and Lara Wright, second alternate. The renewal scholarship was awarded to Tandy Thornton Harshbarger.
