

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
JULY 26, 1993

The Board of County Commissioners met as the County Board of Equalization on this date at 9:00 a.m. with Buzz Wassenberg, Stuart McKinley, John Crow, Laurel Calmes of Merit Reporting Group, and Scott Thompson of the Pinedale Roundup. In the absence of Chairman Monte Skinner, Commissioner Wassenberg assumed the chair.

The formal protest from Irv Lozier on a mobile home located at Kerback Trailer Court was reviewed. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to deny any adjustment to the protested assessment. The motion carried.

The formal protest from Ray F. & Dixie L. Bredthauer on Lot 3, Block 3, Redstone IV Addition was presented. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to deny any adjustment to the protested assessment. The motion carried.

The formal protest from Ray F. Bredthauer on Lots 16 & 17, Rendezvous Subdivision was presented by the Bredthauers. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to allow the adjusted assessment of \$89,758 and directed the County Assessor to issue an abatement order for 1992 taxes paid. The motion carried.

The formal protest from Ray F. & Dixie L. Bredthauer on Lot 2, Block 10, Hennick 2nd Addition was presented by the Bredthauers. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to deny any adjustment to the protested assessment. The motion carried.

The formal protest from Ray F. & Dixie L. Bredthauer on Lots 20, 21, 22, and 23, Block 6, Midway Subdivision was presented by the Bredthauers. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to allow an adjustment of assessment to \$500. The motion carried.

The formal protest from Joseph R. & Edna E. Hicks for part of the SW $\frac{1}{4}$ NE $\frac{1}{4}$, part of the NW $\frac{1}{4}$ NW $\frac{1}{4}$, S $\frac{1}{2}$ NW $\frac{1}{4}$, all of Section 35, and SE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 34, T37N, R110W was presented by Mr. Hicks. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to allow the adjustment of assessment upon the submission of documentation from Kip Alexander and Heidi Wilson as to the agricultural use and continued agricultural use on said property within 10 days of hearing. The motion carried.

The formal protest from Redstone Corporation for the SW $\frac{1}{4}$, Section 18, T36N, R100W, was presented by Joe Hicks. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to allow the adjustment of assessment upon the submission of documentation from Kip Alexander and Heidi Wilson as to the agricultural use and continued agricultural use on said property within 10 days of hearing. The motion carried.

The formal protest from Richard E. Janousky for Lot 130, Block 3, Barger Subdivision was reviewed. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to deny any adjustment to the protested assessment. The motion carried.

The formal protest from Ronald and Frances Chilcote for Signal Hill Subdivision was reviewed. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to deny any adjustment to the protested assessment. The motion carried.

The formal protest from John Frullo for a summer home on the south shore of Fremont Lake was reviewed. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to deny any adjustment to the protested assessment. The motion carried.

The formal protest from Everett C. and Mary C. Ransdell for Lot 7, Trails End Subdivision was reviewed. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to deny any adjustment to the protested assessment. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to deny any adjustment of the protested assessments from the residents of Boulder Lake Country Estates. The motion carried.

The formal protest from Maurice W. Crow, represented by Betty Dooley, by phone, for the N $\frac{1}{2}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$, NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 29, T31N, R106W, was discussed. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to tavel a decision for 10 days for a copy of the agricultural lease for said property. The motion carried.

The formal protest from Phillip F. Haas for the E $\frac{1}{2}$ SE $\frac{1}{4}$, Section 3, T31N, R109W, was reviewed. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to allow the adjustment to agricultural for the protested assessment. The motion carried.

The formal protest from Amoco Production Company was reviewed. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to reject the protest and refer it to the State Board of Equalization. The motion carried.

The formal protest from Exxon Corporation was withdrawn.
