

The Board directed the County Clerk to advertise for the plowing for Skyline Drive.

Action on the Willow Lake CR 23-119 was tabled due to questions concerning power easements until the December 7th meeting.

In accordance with the public notice published in the Pinedale Roundup on October 28, 1993, public hearing was held for the following:

1. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to accept and act upon the recommendation of the Planning and Zoning Commission. Upon vote, the motion carried and the following resolution was adopted:

RESOLUTION NO. 93-410S

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF JEFFREY M. AND SHERRY K. THIERRY TO RECLASSIFY AND REZONE 10 ACRES, MORE OR LESS, FROM A-1 DISTRICT TO R-R 10 DISTRICT, BEING PART OF THE W1/2NE1/4 OF SECTION 27, T34N, R111W.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to sign the Hunt Lot Division. The motion carried.

Marlenn Wise and Les Staley discussed the completion of the remodeling of the Sublette Hi-Country Senior Citizens Center.

George Staidl and a group of residents from south of Pinedale expressed their concerns about the proposed location of an emergency storage tank at the Pinedale Sewer Lagoon. A petition with 30 signatures was presented to the Board protesting the location. Mayor Miriam Carlson informed the group that the Pinedale Town Council will be holding a public hearing on the matter on November 18, 1993, at 6:30 p.m. County Attorney John Crow stated that Sublette County has not received an application for the location. Ed Wood informed the group that the facility may not be needed. The Board thanked the group for informing them of their concern and encouraged them to attend the public hearing on the 18th.

Ed Wood, representing Burleigh Binning, presented a contract for the Board to review for the purchase of a crusher. The Board took no action on the contract and requested a list of all equipment and offered \$332,200 for a purchase price for Binning to consider.

County Attorney discussed pursuing the establishment of a County Court system.


The Board decided to send a letter protesting instream flow to the State Engineer.
