

Sheriff Jack Cain inquired if the Board would transfer funds received from the settlement on the 1993 Bronco to his budget to assist with his hiring of new personnel. The Board assured Cain that when the funds are received, it will be transferred. The charging of meals for search and rescues was discussed and Cain was informed that by resolution and statute, expenses are reimbursable.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to adopt W.S. 8-4-101 and establish the county holidays for 1994. The motion carried. The County holidays will be: January 17, Martin Luther King, Jr., Wyoming Equality Day; February 21, President's Day; May 30, Memorial Day; July 4, Independence Day; September 5, Labor Day; November 11, Veterans Day; November 24 and 25, Thanksgiving; December 26, Christmas; and January 2, 1995, New Year's Day.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to adopt Resolution No. 93-416S establishing a County Court in Sublette County and providing for an effective date and date of commencement. The motion carried.
