

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
FEBRUARY 1, 1994

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Monte Skinner, Buzz Wassenberg, Stuart McKinley, Pat Schmid, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of January 18, 1994, were approved and ordered filed on motion by Commissioner Wassenberg and seconded by Commissioner McKinley. The motion carried.

The official bonds for Sally Hayward, Treasurer for the Pinedale Airport Board, in the amount of \$1,000; Misty J. Haehn, Secretary/Treasurer for the Sublette County Fire Fighters Association, in the amount of \$50,000; and Penny Chrisman, Treasurer for the Sublette County Fair Board, in the amount of \$2,000 were approved and ordered filed with the County Treasurer.

Annie Weber, Public Health Nurse, discussed legislation and it was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to endorse the appointment of Dr. David Burnett and Sue Holz to the Public Health Professional Advisory Board. The motion carried.

Sealed bids were opened for the purchase of a one-ton chassis and two 3/4 ton pickups for the Road & Bridge Department. Bids were received from Frontier Ford and Greiner Ford. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to award the bid to Frontier Ford for the following amounts:

one-ton chassis with automatic transmission: \$13,975.60  
3/4 ton pickups with 5 speed transmission: 14,535.60

The motion carried.

Mike McGinnis, Road & Bridge Superintendent, reported on the possible purchase of scales.

Brian Dunphy and Will Harrison of Exxon Company, discussed the recent directive from the Oil and Gas Commission concerning the venting of CO<sub>2</sub>.

Bob Reese and Greg Clark of the Forest Service, reported on projects within the county.

Senator Bob LaLonde and Representative Budd Betts discussed the upcoming legislative session and inquired about possible bills the Commissioners need sponsored.

Sheriff Jack Cain presented his department's December reports, reviewed the overages in his budget, discussed pending lawsuits, and inquired about search and rescue training. The Board denied the request for funds for a search and rescue training due to lack of funds and returned a voucher in the amount of \$150 for further documentation.

Steve Mackey reported on the Pinedale Airport Board and the Board instructed Mackey to make application for the Airport Board for liability insurance.

Bob Johnson presented a mutual aid agreement for consideration for emergency situations. The Board referred the agreement to the County Attorney for review.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to issue a beer permit to the Pinedale Snow Explorers for the Pinedale Hillclimb at White Pine on February 12 and 13, 1994. The motion carried.

The following petition and affidavit of abatement of taxes was presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Glade B. & Beth L. Jones, Riverside Livestock, \$156.46.
