OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
APRIL 5, 1994

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Monte Skinner, Buzz Wassenberg, Stuart McKinley, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of March 15, 1994, and special meeting of March 30, 1994, were approved and ordered filed on motion by Commissioner Wassenberg and seconded by Commissioner McKinley. The motion carried.

Paul Scherbel presented a map of the County Fairgrounds.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to adopt Resolution No. 94-418S authorizing the Board of County Commissioners to apply for a right of way from the Bureau of Land Management and authorizing Chairman Monte B. Skinner to sign the application and any other documents in the name of the Board and County. The motion carried.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to adopt Resolution No. 94-419S authorizing the Board of County Commissioners to apply for a right of way from the State of Wyoming and authorizing Chairman Monte B. Skinner to sign the application and any other documents in the name of the Board and County. The motion carried.

The Board signed a lot division plat for Hoback Ranches, Tract 18, Sheet 8.

Jerry Tully questioned the liability of the drop-off at the transfer station and suggested signs, inquired about oiling South Bench road, and requested a written statement from the Board regarding his liability in the stock driveway adjacent to his property. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to request a written statement of liability from County Attorney John Crow and forward it to Mr. Tully. The motion carried and the County Clerk was directed to forward Crow's letter.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to adopt Resolution No. 94-420S authorizing transfer of county funds in the following amounts:
