

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

The Board of County Commissioners and Sublette County Fair Board met in special session on this date at 7 p.m. at the Sublette County Fairgrounds north of Marbleton, Wyoming, for the purpose of receiving public comment on the proposed construction of a multi-purpose arena to be located at the Sublette County Fairgrounds. The hearing was attended by 86 people.

Penny Chrisman, Fair Board Treasurer, and Bob Beiermann, Arena Committee, presented the site and building plans to the public.

Fair Board Chairman Ed Taylor received comments from the public.

Comments were made by Jane Wardell, Tara Miller, Doug Vickrey, Pam Ready, Steve Mitchell, Dudley Key, Brian Espenschied, Dan Gilbert, Lynda Vickrey, Spencer Nichols, Dr. David Burnett, Vicky Taylor, Monte Skinner, Spike Daniels, Buzz Wassenberg, Nancy Espenschied, Louie Tomassi, Jess Griffin, and Mike Preston.

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
MAY 17, 1994

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Monte Skinner, Buzz Wassenberg, Stuart McKinley, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of May 3, 1994, and public hearings of May 3 and 5, 1994, were approved and ordered filed on motion by Commissioner Wassenberg and seconded by Commissioner Skinner. The motion carried.

After discussion with the County Elected Officials, it was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to adopt Resolution No. 94-425S, in accordance with W.S. 18-3-107, as amended, to establish the salaries for the County Assessor, County Clerk, Clerk of District Court, County Sheriff, and County Treasurer to be \$35,500 commencing January 2, 1995, \$37,000 commencing January 1, 1996, \$38,500 commencing January 1, 1997, and \$40,000 commencing January 1, 1998, for the ensuing four-year term. It was also moved to establish the Prosecuting and County Attorney salary to be \$50,000 commencing January 2, 1995, \$53,500 commencing January 1, 1996, \$57,000 commencing January 1, 1997, and \$60,000 commencing January 1, 1998, for the ensuing four-year term. The motion carried. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to establish the salaries for the County Commissioners to be a cap of \$12,000 annually, with each Commissioner electing to accept the salary, and with each Commissioner receiving \$100 for each meeting in excess of the two regularly scheduled monthly meetings, commencing January 2, 1995, for the ensuing four-year term. The motion carried.

Dick and Nancy Stott of Lakeside Lodge, and Frank Deede of Half Moon Lake Guest Ranch, discussed establishing a fee schedule for restaurant liquor licenses. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to adopt Resolution No. 94-426S establishing the rate of \$300 for up to \$5,000 in gross liquor sales, with \$50 per \$1,000 in sales, up to \$625, annually, effective July 1, 1994. The motion carried.

Commissioner Wassenberg excused himself from the remainder of the meeting.

Arlan Hiner of the BLM reported on current projects and informed the Board that the archeology for the Cottonwood-Ryegrass Road would take 2-3 years to complete and advised the Board to consider a private consultant for the project.

In accordance with the public notice published in the Pinedale Roundup on April 28, 1994, public hearing was held for the following:

1. It was moved by Commissioner McKinley and seconded by Commissioner Skinner to accept and act upon the recommendation of the Planning and Zoning Commission. Upon vote, the motion carried and Resolution No. 94-424S was adopted adding Chapter IX, Flood Plain Management, to the Sublette County Zoning and Development Regulation Resolution.

2. It was moved by Commissioner McKinley and seconded by Commissioner Skinner to deny the variance request by Ray and Anita Wall to allow placement of a mobile home on Lot 8, Pocket Creek Ranches Subdivision.

Bob Reese and Jim Keller of the Forest Service, continued the discussion on the tax lien on the White Pine property and were again informed that the County intends to collect the taxes due. Reese updated the Board on the Rainbow Family activities and the Town of Pinedale water project.
