

1. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to accept and act upon the recommendation of the Planning and Zoning Commission. Upon vote, the motion carried, and the following resolution was adopted:

RESOLUTION NO. 94-427S

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF BRUCE C. GOOCH TO RECLASSIFY AND REZONE 26.6 ACRES, MORE OR LESS, FROM A-1 DISTRICT TO R-R 5 DISTRICT, BEING THE E1/2NW1/4, NW1/4NE1/4, OF SECTION 33, T34N, R109W.

2. It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to grant approval to the preliminary plat for Stream Side Subdivision, Bruce C. Gooch, developer, with the following stipulations:

- a. Net and gross lot acreage and flood elevations be placed on the map.
- b. Following statements shall be placed on the final map:
 1. Fencing across Pine Creek shall be allowed only on exterior lot lines, no fencing of Pine Creek within the interior of the lot is allowed.
 2. Structures shall be placed in the designated building envelopes.
 3. Septic system leachfields shall be placed in the designated areas.
 4. Road and sewer lines shall be placed in the designated areas.
 5. No sewer line shall be located in a roadway.
 6. Individual lots shall be required to connect to the Town of Pinedale sewer when any lot line on the property is within 440 feet of the sewer line.
- c. Army Corp permits be obtained for driveway and septic lines crossing all applicable areas.
- d. Building envelopes shall be placed on the plat out of the wetlands and the ten year floodplain.

The motion carried.

Mark Eatinger, Rio Verde Engineering, reported on the Town of Pinedale water study.

The Board directed Misty Haehn, Planner, to pursue regulations for 35+ acre development.

Noting that there were no objections, it was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to adopt Resolution No. 94-428S allowing the Board to proceed with the alteration of Paradise County Road No. 23-136. The motion carried.

Mayor of Pinedale, Miriam Carlson, requested that the Board consider incorporating the Town animal control officer into the County Law Enforcement. The position would continue to be funded by the Town of Pinedale. The Board deferred any action to a later date.

Sheriff Jack Cain reported on law enforcement for the Rainbow Gathering. Accounting for expenses and their reimbursement were discussed.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to issue beer permits to the Sublette County Historical Society for Rendezvous, July 9, 1994, at the Rendezvous Grounds, and to the Chuckwagon Days Committee for July 2, 3, and 4, 1994, at the Fairgrounds for Big Piney Chuckwagon Days. The motion carried.

Rex Poulson and Daphne Platts, representing the Library Board, discussed the County budget.
