

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to adopt Resolution No. 94-435S protesting Rangeland Reform '94 and recommending the use of the communication developed by the Governor's steering committee as a beginning, establishing a two-year moratorium on any new regulatory changes on federal lands, continue meeting and discussing problems and opportunities for the management of federal rangelands within Wyoming, allow other states to develop their own management plans and that Wyoming's recommendations should not be proposed as a model for any other state, that other state's recommendations should not be imposed upon Wyoming, and that when Wyoming's plan becomes a reality, it must be accepted in its totality. The motion carried.

Herman Genetti asked zoning questions regarding his property in Tyler Subdivision and was referred to the Planning and Zoning Commission.

Bucky and Lucy Neely, Lance Koppenhafer, Bob Bing, Todd Stevie, and Bob Klaren discussed the road right of way on CB Lane, its access, and livestock. Apparently the access gate to the ditch has been locked, fences have been cut, and livestock has been loose. It was agreed by the parties present to refrain from cutting the fence, leave the gate unlocked, and repair the fence to contain the livestock. Neelys approved the attachment of the fence to their posts.

Marilyn Jensen, Clerk of District Court, discussed a proposed increase in filing fees with the Board. The Board agreed to support the proposal.

It was moved by Commissioner Wassenberg and seconded by Commissioner McKinley to cancel the September 20th meeting due to the Wyoming Association of County Officers meeting in Sheridan. The motion carried.
