

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
JANUARY 17, 1995

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Stuart McKinley, Bill Cramer, Mike McGinnis, Judy Rhine of the Pinedale Roundup, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of January 3, 1995, were approved and ordered filed on motion by Commissioner McKinley and seconded by Commissioner Cramer. The motion carried.

The official bonds for Adrienne Peterson, Treasurer, Sublette County Weed & Pest, in the amount of \$3,000; and Vicki Brown, Clerk/Treasurer for the Town of Big Piney, in the amount of \$50,000 were approved and ordered filed with the County Treasurer.

Amy Reed, Director of Sublette Community Counseling Service, provided an agency report of activity for the Board.

Mike McGinnis, Road and Bridge Superintendent, reported on the Boulder Lake Road, Willow Lake Road, Daniel-Merna project, divesting the County of the Boulder bridge, and the Calpet Road.

Ed Wood, Deputy County Attorney, discussed the Miner Creek petition. It was moved by Commissioner Cramer and seconded by Commissioner McKinley to appoint Gordon Johnston, viewer, and request a report by the second meeting in February. The motion carried.

Scott Thompson, Emergency Management Coordinator, presented the local procedures guide and its use.

Annie Weber and Marla Vicchy, Public Health Nurses, presented two contracts from the State of Wyoming for signature for immunizations and AIDS and HIV testing and counseling. The Board signed the contracts.

Arlan Hiner, Area Manager for the BLM, reported on postponing the Christmann Land exchange, and other projects.

Bob Reese, District Ranger for the Forest Service, and Tom Burns and Bob Sweedler from School District #1, discussed the Skyline Drive plowing contract. The Board offered the administration of the contract to the school or the Forest Service, due to public complaints about the plowing. No action was taken and the contract will be reviewed by all entities in the spring.

Reese informed the Board about the travel plans meetings and comments, the Willow Lake Road contract to be delivered at the next meeting, the Boulder Lake Road project, and the revival of the Council of Governments this spring.

It was moved by Commissioner McKinley and seconded by Commissioner Cramer to approve and sign the lot division plat for Andy O'Neal. The motion carried and the plat was signed.

The following petitions and affidavits of abatement of taxes was presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Enron Oil & Gas Company, \$12.33; Enron Oil and Gas Company, \$6,194.00; McMurry Oil Company, \$6,994.00; Howell Petroleum Corporation, \$977.00; and Howell Petroleum Corporation, \$104.00.

Ed Wood, Deputy County Attorney, discussed the proposed purchase of a building in Marbleton from Dorothy Marincic. A contract is anticipated to be delivered to the Board by the February 7th meeting.

Wood advised the Board that he would prepare a quit claim deed for the Retirement Center of Sublette County, as opposed to a warranty deed, as earlier advised.

It was moved by Commissioner McKinley and seconded by Commissioner Cramer to appoint Helen Tanner, Dave Bell, and Bruce Anderson to the Sublette County Recreation Board for five years. The motion carried.

It was moved by Commissioner McKinley and seconded by Commissioner Cramer to appoint Ken Shriner, and Bob Beard, for four year terms, and Bill Mayo, to an unexpired two year term on the Sublette County Weed and Pest Board. The motion carried.

It was moved by Commissioner McKinley and seconded by Commissioner Cramer to issue a malt beverage permit to the Pinedale Snow Explorers for February 11 and 12, 1995, for the Pinedale Hillclimb at White Pine. The motion carried.
