OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
April 4, 1995

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Stuart McKinley, Bill Cramer, Janet Montgomery, County Assessor; Mike McGinnis, Judi Rhine of the Pinedale Roundup, Ed Wood, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of March 21, 1995, were amended to change the transfer date for Arlan Hiner of the BLM from April 1 to May 1 and ordered filed on motion by Commissioner McKinley and seconded by Commissioner Cramer. The motion carried.

The official bond for Peter Arambel, Secretary/Treasurer for the Sublette County Predatory Board, in the amount of \$1,000, was approved and ordered filed with the County Treasurer.

Bob Reese, District Ranger for the Forest Service, reported that the travel plan is being reviewed by the Fish and Wildlife Service, informed the Board that environmental assessments will be required for all 1996 grazing permit renewals and that there are 42 existing permits, reported that Sandra Key has been appointed the new Forest Supervisor, stated that the environmental assessment for the wild and scenic rivers is being reviewed in Washington DC, and reported that the environmental assessment for White Pine will be published beginning May 1st for public review with construction planned for this summer and skiing in 1996-97. Reese made a statement regarding the Miner Creek easement and the Forest Service opinion that the Forest Service easement is not administrative, but provided access to the public.

In accordance with the public notice published in the Pinedale Roundup on March 2, 9, and 16, 1995, public hearing was held for the petition requesting abandonment of the Miner Creek easement by John and Cleo Eshelman. Chairman Wassenberg presented a background report on the petition. County Clerk Mary Lankford read the viewer's report, as prepared by Gordon Johnston, presented petitions in opposition, with approximately 425 signatures, to the abandonment of the easement, and reviewed letters in opposition to the abandonment from Pape Ranch, Inc., Jackson Schwabacher, Wyoming Game & Fish Department, John Mortenson, David W. Keller, Jack Schwabacher, Jo & Ron Reckner, Loren Smith, Miles R. Peterson, Phelps H. Swift, Jr., Paul D. Stevens, Brad Frohbieter, and Gordon & Heidi Schwabacher. Lankford presented a letter of support for the abandonment from the Wyoming Field Office of The Nature Conservancy. Bill Twichell, representing the Eshelmans, presented their position for abandonment of the easement. Comments were made by John Eshelman, Gordon Johnston, Gerald Mason, Phelps Swift, Tucker Smith, Cleo Eshelman, Gordon Schwabacher, and Scott Scherbel. It was moved by Commissioner Cramer and seconded by Commissioner McKinley to table any action on the petition until June 6, 1995, and encouraged the parties involved to discuss and resolve the situation before June 6th. The motion carried.

The Board adjourned to view a tee box at Rendezvous Meadows Golf Course in response to a possible encroachment.

The Board reconvened and stated that the tee box in question located on the golf course property and Ed Wood, Deputy County Attorney, will notify the party involved.

Mike McGinnis, Road & Bridge Superintendent, presented the monthly landfill reports and discussed landfill closure. McGinnis reported that DEQ has recently viewed all of the old landfill sites in the county.
