

In accordance with the public notice published in the Pinedale Roundup on March 9, 16, 23, and 30, 1995, public hearing was held for an application for a county malt beverage permit by Samuel B. Martin dba Lakeside Beer Sales at Lakeside Lodge. There being no opposition to the issuance of the permit, it was moved by Commissioner McKinley and seconded by Chairman Wassenberg to issue the permit. The motion carried. Commissioner Cramer was absent.

Commissioner Cramer returned.

Ed Wood, Deputy County Attorney, discussed the Presidio Oil Company settlement and presented a settlement agreement for the amount of \$216,693.83. It was moved by Commissioner McKinley and seconded by Commissioner Cramer to accept and sign the settlement agreement. The motion carried.

Nylla Kunard, County Treasurer, presented proposed investments for signature. The Board approved the investments.

Dr. Bert Reinow, County Sanitarian, discussed the reorganization of food service inspections and the exclusion of certain Sublette County businesses from his inspection. Dr. Reinow proposed refusing to comply unless all businesses were included. The Board expressed its support for the proposal.

Brady Baldwin, representing the BLM, discussed the nomination of three roads within Sublette County for ISTEAs projects, which will be 100% funded. The Board discussed proposing LaBarge Creek CR 23-128, Lander Cutoff CR 23-132, and North Piney/Cottonwood CR 23-143. Mike McGinnis offered to prepare the list and submit it to the BLM.

The Board received a telephone call from Terry Rubald, Chairman of the State Board of Equalization, regarding State Board rules and regulations.

The Board reviewed the remodeling of the Marincic building in Marbleton for budget purposes.

County Assessor Janet Montgomery, Planner Misty Haehn, and Pam Curry discussed the funding for the GIS project. The project will cost approximately \$40,000 with funding provided from:

The first phase of the project will be to purchase the equipment and training. The second phase will be to create the base map and provide its maintenance. It is anticipated that next year's budget will be approximately \$30,000. The Board directed the group to proceed with the project.
