

Sheriff Hank Ruland, Bob Hanson, and Bob Sutherland reported on juvenile detention projects in Vernal, Davis County, and Provo, all in Utah. Sight and sound separation exists in the county jail, as is required, and it was decided to delay pursuing a capital project and continue to collect information. Sutherland reported on Enhanced 911 and the Board encouraged continued study. Preliminary budgets were reviewed for Law Enforcement, Detention, and Communications with regard to the metro contracts. It was decided to inform Marbleton and Big Piney to budget a maximum of \$75,000 and Pinedale \$150,000, with more concrete proposals to be delivered once the County's budget process begins.

Bob Dew and Gregg Anderson, representing the Rural Health Care District, inquired about the County's matching funds for the Pinedale Clinic expansion in the amount of \$25,000 and were assured that the funds were still in place. The Board informed the district members that no commitment had been made to support expansion of the Pinedale Ambulance Barn to the EMT's.

The following petition and affidavit of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Clayton Hasselhuhn, \$49.17.

The applications for the County Commissioners' Tuition Waiver Scholarships were reviewed. Two scholarships were awarded to Big Piney seniors Heather Roufs and Matthew Williams, with Audra McGinnis alternate. One scholarship was awarded to Pinedale High School senior Sara Percy, with Kenna Rodgers, first alternate, and Jamie Walker, second alternate. The renewal scholarship was awarded to Ryan Cothorn.

Mayor Miriam Carlson and council members Rose Skinner and Barbara Boyce, of the Town of Pinedale discussed the hook-ups and adequacy of the lift station west of Pinedale adjacent to the Golf Course subdivision. The council members will inquire about the status of the situation and report back to the Board. The Board and Council members agreed that an agreement to manage the situation is needed and has been submitted for review by the Town attorney. A draft of a joint powers board agreement for the Pinedale Fire Hall was discussed. Concern for the response from the firemen to the agreement was expressed by Boyce. No action was taken on the draft agreement.
