OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
MAY 16, 1995

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Stuart McKinley, Bill Cramer, Marilyn Jensen, Clerk of District Court; Mike McGinnis, Judi Rhine of the Pinedale Roundup, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of May 2, 1995, were ordered filed on motion by Commissioner McKinley and seconded by Commissioner Cramer. The motion carried.

The official bond for Betty Lou McLoughlin, Treasurer for the Upper Green River Cemetery District, in the amount of \$1,000; Patty Racich, Clerk Treasurer for the Town of Pinedale, in the amount of \$50,000; and Robert W. Maxam, Secretary/Treasurer for the Pinedale Volunteer Fire Department, in the amount of \$25,000 was approved and ordered filed with the County Treasurer.

Having been published in the Pinedale Roundup on May 11, 1995, public hearing was held for the transfer of County Funds. It was moved by Commissioner McKinley and seconded by Commissioner Cramer to adopt Resolution No. 95-457W authorizing the transfer of County General Funds as follows:
