Rick Hubbard, Detention employee, presented a request for the difference between his salary and temporary total disability during a recent Workers Compensation claim. The request was referred to the Sheriff's Department.

In response to letters received by the Board from Marilyn Jensen, Clerk of District Court; Janet Montgomery, County Assessor; Nylla Kunard, County Treasurer; and Clark Allen, County Attorney, the Board met with the above to discuss the advertisement for bid for cleaning services. Support for the present cleaning service, B & J Janitorial Services, was expressed by the above elected officials. The lack of a contract and supervision was discussed. Montgomery stated that she would be responsible for the supervision of cleaning and grounds services. The Board decided that it would contract with B & J Janitorial Services for one year at the same price of \$1,700 per month, and directed the County Clerk to cancel the advertisement for bids.
