

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
JULY 5, 1995

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Stuart McKinley, Jim Hutchinson, Dave Trombly, Judi Rhine of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present. Commissioner Bill Cramer was absent.

The minutes of the preceding meetings of June 16, 20, and 26, 1995, were ordered filed on motion by Commissioner McKinley and seconded by Commissioner Wassenberg. The motion carried.

A sealed bid was opened for the excavation of a cell at the Marbleton Landfill from Schmid Sand and Gravel. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to accept the bid of \$.78 per cubic yard at an estimated total of \$42,432.00. The motion carried.

Mike McGinnis, Road and Bridge Superintendent, reported on the slide on the Jack Creek road and possible construction of a french drain at the site. McGinnis discussed the sewer line located west of Pinedale and its repairs, the Boulder Lake Road project and gravel crushing, and certification of freon removal.

It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to issue five malt beverage permits to the Sublette County Sporting Association for June 30, July 7, 8, 9, and September 4, 1995. The motion carried.

It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to issue a malt beverage permit to the Sublette County Historical Society for Rendezvous on July 8, 1995. The motion carried.

It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to waive the \$200 fee for the temporary merchant license in accordance with W.S. 33-20-203(b) for Rendezvous Weekend. The motion carried.

It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to authorize two payments of \$20,000 each to Petersen Landscaping for the landscaping of the Pinedale Fire Hall from the Fire Reserve Fund, upon delivery of acceptable guarantees for the work. The motion carried.

Having been published in the Pinedale Roundup on June 29, 1995, public hearing was held for the transfer of County Cash Reserve Funds. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to adopt Resolution No. 95-463W to authorize the transfer of the following funds:

Letters received from the Pinedale Airport Board regarding insurance and speed limits at the airport were referred to Deputy County Attorney Ed Wood.

Dr. Bert Reinow presented a resolution establishing regulations for a tattoo establishment. No action was taken.

The Board approved and signed the Poulson Lot Division plat.

In accordance with the public notice published in the Pinedale Roundup on June 15, 22, and 29, 1995, no objections were received on the alteration of Paradise County Road No. 23-136.

Elvin Booth discussed installation of a new design cattleguard in Jim Bridger Estates, requested fencing, and requested replacement of survey stakes in Jim Bridger Estates, Seventh Filing. The Board took no action on the cattleguard and fencing and referred the survey stake request to Paul Scherbel.

A claim was presented by Kevin Thomas for damages received from driving over a cattleguard on Cottonwood-Ryegrass County Road No. 23-117. After reviewing the claim, the accident report from the Sheriff's Department, and Mike McGinnis' report, it was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to deny the claim. The motion carried, and the Board directed Ed Wood to notify Thomas.

The Board reviewed the FY96 budget.
