JULY 17, 1995

The Board of County Commissioners met on this date at 8:00 p.m. for the final public hearing on the FY96 budget, in accordance with Wyoming Statute 16-4-109(b), as amended, with Buzz Wassenberg, Stuart McKinley, Bill Cramer, Jim Hutchinson, Hank Ruland, Janet Montgomery, Daphne Platts, Stella McKinstry, Gary Espenscheid, Nancy Espenscheid, Penny Chrismann, Judi Rhine of the Pinedale Roundup, and Mary Lankford, County Clerk present.

Chairman Buzz Wassenberg, presented the proposed budget. Wassenberg discussed the anticipated shortfall for FY97 and the Board's effort to reserve funds to accommodate the shortage.

Jim Hutchinson expressed his opinion that the County was spending too much money and encouraged more conservative spending.

There being no further comments, it was moved by Commissioner Cramer and seconded by Commissioner McKinley to adopt the Appropriation Resolution and the Resolution to Provide Income Necessary to Finance the Budget for the FY95 budget. The motion carried.
