

2. Preliminary plat approval for Buffalo Head Estates II Subdivision, zoned R-R 5/PUD consisting of 70.10 acres to be divided into 10 lots. Planning and Zoning Administrator Misty Haehn reviewed the application and informed the Board of the Planning and Zoning Commission's decision to deny the application for the following reasons:

- Sublette County Subdivision Resolution Chapter II, Section 7:
- A. The proposed subdivision does not conflict with the goals of the Comprehensive Plan, and will be consistent with all applicable elements thereof.
  - E. The proposed subdivision will not have any significant adverse impact on the County's scenic resources.
- and void of assurance from the Army Corp of Engineers that designated roads crossing wetlands will be permitted.

A letter in opposition to the application from the Root Company.

Steve Duerr, representing Pitchfork Development Company, LLC, presented the application and discussed the denial of the application by the Planning and Zoning Commission. Opposition to the application was expressed by William Kellen, Otis Carney, Teddy Carney, Dennis Gralund, and with a petition with 59 signatures. Deputy County Attorney Ed Wood advised the Board of its two options: to approve or disapprove the Planning and Zoning Commission's recommendation to deny the application within 30 days. The Board agreed to delay a decision until the next regular meeting on September 5, 1995, and directed Haehn to submit the petition presented to the Board by the Upper Green River Association to the Planning and Zoning Commission for consideration.

3. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to approve and sign the Merritt Lot Division plat. The motion carried and the plat was signed.

Fred Petersen of Petersen Landscaping discussed the denial of his voucher for the amount of \$7,000 for the completion of the Pinedale Fire Hall. The Board reviewed the information and took no action.


