

Fred Petersen of Petersen Landscaping discussed the denial of payment of an additional \$7,000 for the landscaping of the Pinedale Fire Hall. It was moved by Commissioner Cramer to approve payment in the amount of \$4,000. The motion died, due to lack of a second.

Nylla Kunard, County Treasurer, discussed the sale of the cabins at White Pine, and the reluctance of the purchaser to pay the delinquent taxes. Kunard informed the Board that she intends to recover the entire tax amount owed.

The Board authorized the repayment of taxes on property sold at the County tax sale on a certificate of purchase, on property donated to Sublette County.

It was moved by Commissioner Cramer and seconded by Commissioner McKinley to deny the petition for abatement of tax from Hunt Oil for economic obsolescence in the amount of \$1,293.07. The motion carried.
