OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
NOVEMBER 7, 1995

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Stuart McKinley, Jim Hutchinson, Dave Trombly, Mike McGinnis, Judi Rhine of the Pinedale Roundup, and Mary Lankford, County Clerk present. Commissioner Bill Cramer was absent.

The minutes of the preceding meeting of October 17, 1995, were approved and ordered filed on motion by Commissioner Wassenberg and seconded by Commissioner McKinley. The motion carried.

The official bonds for Ann Fear, Treasurer for Sublette County School District #1, in the amount of \$25,000; Paul C. Hagenstein, Treasurer for the Sublette County Museum Board, in the amount of \$1,500; and the Pinedale Airport Board, in the amount of \$5,000, was approved and ordered filed with the County Treasurer.

Sealed bids were opened for the purchase of two dump trucks with snow equipment. Bids were received from Lariat International Trucks, Inc.; Lake City International Trucks, Inc.; Casper Truck Center, Inc.; and Tri State Truck & Equipment, Inc. It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to award the bid for two 2674 International dump trucks with Holland snow removal equipment to Lake City International Trucks, Inc., for the amount of \$173,905. The motion carried.

Mike McGinnis, Road & Bridge Superintendent, presented the monthly landfill reports, and reported that the Wyoming Department of Transportation in Jackson has requested use for the County's Bondurant building for the parking of a snow plow. The Board discussed the request and approved the use and will request payment for part of the electrical bill in the spring. McGinnis reported on projects and presented a request from Teton County to allow Teton County tires to be stored at the Marbleton Landfill and shedded there. The Board approved the request at no cost.

It was moved by Commissioner McKinley and seconded by Commissioner Wassenberg to adopt Resolution No. 95-474W altering Merna North Beaver County Road No. 23-115, through Section 28 of T35N, R113W, to conform to the location as depicted on the plat for Jim Bridger Estates Subdivision, Seventh Filing. The motion carried.
