

OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
DECEMBER 5, 1995

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Stuart McKinley, Bill Cramer, Jim Hutchinson, Dave Trombly, Dan Holgate, Judi Rhine of the Pinedale Roundup, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of November 21, 1995, were approved and ordered filed on motion by Commissioner McKinley and seconded by Commissioner Wassenberg. The motion carried.

The official bond for J. Michael Lamp, Big Piney Municipal Judge, in the amount of \$1,000, was approved and ordered filed with the County Treasurer.

The Board discussed revising and developing a snow plowing policy. It was decided to prepare a map depicting the current plowing and make the appropriate policies.

Bob Maxam, representing the Wyoming Department of Transportation, discussed the SC-CFM funds with regard to the Calpet project. It was decided that the appropriate repair would be a cold inplace-recycle with an overlay of 4 inches with 2 inch lifts. No further action was taken at this time.

The following petitions and affidavits for abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Washington Energy Exploration, Inc., \$4,728.72; Noble Excavating, \$72.53; and Noble Construction, \$521.71.

The Board reviewed a request from the Southwest Sublette County Pioneers regarding the purchase of carpet and vinyl and decided that the Board would cover emergency facility expenses up to \$1,000, if the seniors' savings account is depleted.

County Attorney Clark Allan reviewed his projects.

It was moved by Commissioner Cramer and seconded by Commissioner McKinley to appoint Sallie Waters to the Sublette County Fair Board for a five-year term. The motion carried.

It was moved by Commissioner Cramer and seconded by Commissioner McKinley to appoint Steve Laster to an unexpired two-year term and Dave Belford to a five-year term to the Sublette County Recreation Board. The motion carried.

Bethany Walker, Dave Bell, and Rita Thomas, representing the Recreation Board, discussed the possible funding shortfall for next year's budget and informed the group that fees and dues may need to be adjusted to accommodate the situation. Commissioner Wassenberg informed the group that recreation would have a low priority, due to funding statutory services and advised that funding will be limited to youth activities, if it is available. The Board expressed its desire to see the Golf Course become self-supporting. Since no members of the Golf Committee were present, the Board directed the County Clerk to advise the committee of the discussion.

Bob Reese, District Ranger, reported on the vegetation project at Boulder Lake and the displacement of permittees, progress at White Pine, domestic and big horn sheep problems, the travel plan appeal, construction on Union Pass lack of funding, and the agency's move to new office location.

Deputy County Attorney Ed Wood presented the findings of fact and conclusions of law in the Kozola State Board of Equalization appeal. The Board reviewed the document and signed it.

Bob Hanson and Bob Sutherland, representing the Sheriff's Department, requested funding of the replacement of the breathalyzer, which is not repairable. The Board approved the request, which cost approximately \$6,000.

It was moved by Commissioner Cramer and seconded by Commissioner Wassenberg to recommend Commissioner Stuart McKinley to the BLM for its Mineral Committee. The motion carried.
