OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
APRIL 16, 1996

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Stuart McKinley, Bill Cramer, Jim Hutchinson, Dave Trombly, Janet Montgomery of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of April 2, 1996, were ordered filed on motion by Commissioner Cramer and seconded by Commissioner McKinley. The motion carried.

The official bond for Robert W. Maxam, Secretary/Treasurer for the Pinedale Volunteer Fire Department, in the amount of \$25,000 was approved and ordered filed with the County Firefighters Association.

In accordance with the public notice published in the Pinedale Roundup on April 11, 1996, public hearing was held for the transfer of funds in the amount of \$59,346.31 from Unanticipated Revenue-Equipment Lease, E-911 to Communications, E-911. It was moved by Commissioner Cramer and seconded by Commissioner McKinley to adopt Resolution No. 96-494W authorizing the transfer of funds. The motion carried.

Annie Weber, Public Health Nurse, presented the State AIDS contract for signature. It was moved by Commissioner Cramer and seconded by Commissioner McKinley to approve and sign the contract which provides a payment of \$25 per person per test for AIDS services from the Public Health Nurse. The motion carried.
