

Sealed bids were opened for the mowing of barrow pits along County roads. Two bids were received. It was moved by Commissioner Cramer and seconded by Commissioner McKinley to award the bid to Fred Freeman for the amount of \$14.00 per mile. The motion carried.

The Board approved the request to have the County Treasurer pay freon disposal bills directly from funds collected for freon disposal.

Ken Konicek of Tegeler and Associates, discussed the health insurance renewal effective September 1st, which will increase 12%. Konicek discussed converting the County's program to a self-insured program, which the Board approved. The Board directed Konicek and the County Clerk to meet with a group of County employees to discuss co-insurance percentages and deductibles and return with a recommendation by the next meeting.

The Board approved the payment by the County Treasurer of two vouchers for the Cora Y Mosquito District.

Nylla Kunard, County Treasurer, presented a proposed investment policy. The Board tabled any action on the policy until their next meeting. Kunard advised the Board that she will be attending an investment seminar and encouraged the Board to provide her with any questions.

Sheriff Hank Ruland and Detention Administrator Bob Sutherland discussed department staffing and problems with the radio. The Board was advised that it has been suggested to move the base radio to Mt. Airy to alleviate the problem. The move will require additional funding. The Board approved the action and the request for funding, in the amount of \$2,700. Ruland advised the Board that he is not able to charge for breathilizer testing, except for drivers license compliance.

Annie Weber, Public Health Nurse, presented her budget for signature to submit to the State of Wyoming. The Board signed the budget. Weber reported that her agency will be assisting Lincoln County with immunization clinics, as they have lost staff members.

Bob Reese, District Forest Ranger, reported on the Boulder Lake Road project, roads and bridges inspections, the forest highway program, and trails.

It was moved by Commissioner McKinley and seconded by Commissioner Cramer to appoint Chris Hoefer to an unexpired term on the Golf Committee. The motion carried.

It was moved by Commissioner Cramer and seconded by Commissioner McKinley to cancel the September 17th meeting, due to the Wyoming Association of County Officers meeting in Cheyenne. The motion carried.

Jerry Wilson, Daphne Platts, Barbara McKinley, and Rex Poulsom representing the Library, discussed the construction project and its excavation. Fill disposal was discussed, with the County committing to provide on-site fill. The Board directed that the interest earned on the \$316,400, in its Depreciation Reserve Account for the Library Construction, be added to the account.

The Board discussed Sunday opening for county liquor license holders, and tabled any action until its August 22nd meeting.

It was moved by Commissioner McKinley and seconded by Commissioner Cramer to designate the County Clerk Mary Lankford to act as agent on behalf of the Board of County Commissioners to accept the qualified bid for the paving project in the Sublette Golf Course Subdivision and adjacent county road.
