OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
AUGUST 22, 1996

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Stuart McKinley, Bill Cramer, Jim Hutchinson, Jill Johnson of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of August 6, 1996, were ordered filed on motion by Commissioner Cramer and seconded by Commissioner McKinley. The motion carried.

The official bond was approved for Eva C. Kallas, Director of Sexual Assault and Family Violence, in the amount of \$20,000, was approved and ordered filed with the County Clerk.

Mike McGinnis, Road & Bridge Superintendent, reported on the surfacing of the roads in the Sublette Golf Course Subdivision and the Daniel-Merna project.

Paul Scherbel reported that Bill Mayo is willing to incur the cost of adverse possession of the Big Sandy South road to secure a county road. The Board requested the offer be presented in writing from Mayo. It was decided to delay any action until written verification is received.

It was moved by Commissioner Cramer and seconded by Commissioner McKinley to adopt Resolution No. 95-512W stating that it will incite procedures at its regular meeting on September 17, 1996, to obtain the necessary easements by adverse possession or prescription in accordance with Section 24-1-101 from Ida M. Youngner and Cynthia Bird Condelle so that the designation of the Big Sandy County Road 23-105 as a County road may be accomplished. The motion carried.
