

The Board directed the County Clerk to contact an insurance consultant to prepare specifications for the bidding of the County's liability insurance this spring.

It was moved by Commissioner McKinley and seconded by Commissioner Cramer to approve the signing of an amended lease contract for the E-911 system. The motion carried.

The following petitions and affidavits of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Enron Oil & Gas Company, \$8,69; Wexpro Company, \$77.61; Hunt Oil Company, \$439.69; and Chevron USA, Inc., \$642.33.

In accordance with the public notice published in the Pinedale Roundup on November 28, 1996, public hearing was held for the following:

1. It was moved by Commissioner McKinley and seconded by Commissioner Cramer to accept and act upon the recommendation of the Planning and Zoning Commission. Upon vote, the motion carried, and the following resolution was adopted:

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF SEARLE BROTHERS CONSTRUCTION COMPANY TO RECLASSIFY AND REZONE 7.49 ACRES, MORE OR LESS, FROM A-1 DISTRICT TO R-R 10 DISTRICT, BEING PART OF THE S1/2NW1/4 OF SECTION 28, T35N, R113W.

2. Preliminary plat application by Carmichael Hill Limited Liability Company to subdivide 51.89 acres into 22 residential lots with an average density of 2.36 acres per lot zoned R-R. Comments were made by Craig Crandall, Melvin Bagley, Commissioner McKinley, John Wetstein, Scott Scherbel, Ken McLaughlin, and Ralph Herbert. It was moved by Commissioner Cramer and seconded by Commissioner Wassenberg to approve the preliminary plat application with the following conditions:

- a. A letter from the Highland Irrigation District stating their conditions of approval have been met and completed.
- b. A note on the plat granting a right of use for the extension of the roads, water and sewer lines through the private subdivision roads to the adjacent properties for future development.
- c. The north access be removed from the plat and a cul-de-sac which terminates prior to the existing road be added.

The motion carried, with the vote being: Wassenberg-aye, Cramer-aye, and McKinley-nay.

It was moved by Commissioner Cramer and seconded by Commissioner McKinley to adopt Resolution No. 96-528W regarding R.S. 2477 rights of way. The motion carried.

The Board closed the meeting to the public for an executive session to discuss pending litigation.

The Board reopened the meeting and it was moved by Commissioner Cramer and seconded by Commissioner McKinley to sign contracts with James Smith and Chuck Norman and Davis & Cannon. The motion carried.
