

been issued for the Dog Sled Race and the Pinedale Hillclimb; the Environmental Assessment preparation for the Pinedale water line; reported on timber sales, road reconstruction on Skyline Drive and Green River Lakes Road; and the Environmental Impact Statement preparation for Moxa Arch, Fontenelle, and the Jonah Field.

In accordance with the public notice published in the Pinedale Roundup on January 30, 1997, public hearing was held for a Local Law Enforcement Block Grants Program grant in the amount of \$12,488. It was moved by Commissioner Johnston and seconded by Commissioner Cramer to accept the grant and approve the purchase of new bullet-proof vests for the Sheriffs Department for approximately \$7,000. The motion carried.

Roxanna Jensen, representing the Fair Board, presented a request to decrease the number of members on the Fair Board from six to five. It was moved by Commissioner Johnston and seconded by Commissioner Cramer to decrease the number of members from six to five and appoint Cynde Guio to fill the unexpired term vacated by Penny Chrisman. The motion carried.

Jensen requested a used County pickup for use at the Fair Grounds. Sheriff Hank Ruland reported that his department would have a pickup available this summer for transfer to the Fair Board.

Deputy County Attorney Ed Wood presented the annexation petitions for the Golf Course Subdivision. It was moved by Commissioner Cramer and seconded by Commissioner Johnston to approve the petitions. The motion carried.

Adrianne Peterson presented the Remedial Agreement for the North Fork Fisherman Creek Gravel Pit. It was moved by Commissioner Cramer and seconded by Commissioner Johnston to approve and sign the agreement. The motion carried.

Prosecuting and County Attorney Clark Allan and Sheriff Hank Ruland discussed the addition of a full-time investigator to the County Attorney's Office. The position would be assigned from the Sheriff's Department and funded by the County Attorney's budget. Chairman Wassenberg expressed his concern about increasing the cost of law enforcement. The Board took no action at this time, and advised Allan to submit the request during the budget process.

The Board discussed speed limits with Ruland and Undersheriff Henry Schmidt and were advised that Resolution No. 87-144T is valid, if the limits are posted. The Board directed that the roads be posted with the appropriate speed limits.

Garry Eiden, Sr. discussed recycling in the Big Piney area and possible funding. The Board advised that funding could be provided to a non-profit organization.

It was moved by Commissioner Cramer and seconded by Commissioner Johnston to approve and sign affidavits to be filed with the State Board of Equalization. The motion carried.
