OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
MARCH 4, 1997

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Bill Cramer, Gordon Johnston, Dave Trombly, Jim Hutchinson, Dan Holgate, Deputy County Attorney Ed Wood, Cat Urbigkit of the Pinedale Roundup, Rob Shaul of the Sublette County Journal, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of February 20, 1997, were approved and ordered filed on motion by Commissioner Cramer and seconded by Commissioner Johnston. The motion carried.

The official bonds for James P. Meiring, Commissioner for the Highland Irrigation District, in the amount of \$1,000; and Alice Griggs, Clerk Treasurer for the Town of Marbleton and The GECC, in the amount of \$165,000 were approved and ordered filed with the County Treasurer.

Commissioner Johnston reviewed a comparison document prepared by Fremont County Commissioner Crosby Allen of the proposed BLM regulations and advised the Board that there are no significant changes proposed and suggested no action on the regulations.

Paul Scherbel discussed RS 2477 and its effect on the establishment of the Willow Lake Road as a County Road. Scherbel was directed to continue pursuit of the BLM easement.

A letter from Frank Grimes of Nelson Engineering was discussed regarding the acquisition of 160 acres adjacent to the Marbleton Landfill by Teton and Sublette Counties. After discussion, it was moved by Commissioner Johnston and seconded by Commissioner Cramer to authorize Grimes to pursue the acquisition through the Federal Land Policy Management Act (FLPMA) process. The motion carried.

A letter from Dave and Holly Hoag regarding drainage adjacent to their property in Shelter Park was discussed. The matter was tabled, until the it could be discussed with Mike McGinnis.

Deputy County Attorney Ed Wood reviewed materials from Davis and Cannon.

County Treasurer Nylla Kunard and County Assessor Janet Montgomery discussed a letter received from the Department of Revenue regarding a payment of \$791,558.00 in taxes by Exxon and the remaining \$414,344.79 being held in escrow. It was decided to hold the funds until our consultants could review the matter.

Kunard reported on the Homeowners Tax Relief Bill and how she intends to provide information to the public.

The Board approved a request to purchase a new postage machine.

The Board approved a request to install a computer networked with the County's mainframe at the County annex in Marbleton.

Sheriff Hank Ruland and Bob Sutherland discussed radios and equipment locations, with the possibility of locating equipment on Mr. Airy. Ruland discussed inmate telephone call policy and difficulties with Public Defender Keith Goody and his clients and telephone calls.

It was moved by Commissioner Johnston and seconded by Commissioner Cramer to approve the issuance of a malt beverage permit to the Pinedale Snow Explorers for an Oval Race held on March 2, 1997, at Sage Brush Downs. The motion carried.
