OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS  
MAY 20, 1997

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Gordon Johnston, Jim Hutchinson, Dave Trombly, Cat Urbigkit of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present. Commissioner Bill Cramer was absent.

The minutes of the preceding meeting of May 6, 1997, were approved and ordered filed on motion by Commissioner Johnston and seconded by Commissioner Wassenberg. The motion carried.

The official bond for Patty Racich, Clerk Treasurer for the Town of Pinedale, in the amount of \$50,000 was approved and ordered filed with the County Treasurer.

Commissioner Johnston reported on a request from the Wyoming Game and Fish for assistance from Road and Bridge in Bondurant to help curb flooding on a feedground. The Board directed that equipment be furnished to satisfy the request.
