Upon vote, the motion carried, and the following resolution was adopted:

It was moved by Commissioner Johnston and seconded by Commissioner Wassenberg to approve the renewal applications for the following retail malt beverage permits: Hoback Village, Elk Ridge Lodge, Inc., Lakeside Beer Sales, and Stanley's Junction Food Mart, subject to the receipt and approval of their application by the Wyoming Liquor Division. The motion carried.

It was moved by Commissioner Johnston and seconded by Commissioner Wassenberg to approve the renewal application for a limited retail liquor license to the Pinedale Golf Club, Inc. The motion carried.

The Board closed the meeting to the public for an Executive Session to discuss the Exxon matter.

The Board reconvened and signed the request for Search and Rescue Reimbursement.

In accordance with the public notice published in the Pinedale Roundup on May 15, 1997, public hearing was held for the purpose of discussing the proposed Community Development Block Grant application by The Learning Center in the amount of \$250,000, for the construction of a new building. Judy Montague and Martha Ptasnik, representing The Learning Center, were present to discuss the project. No comments were received from the public, and the Board expressed its support for the application.

In accordance with the public notice published in the Pinedale Roundup on May 15, 1997, public hearing was held for the transfer of funds in the amount of \$12,000 from Cash Reserve to Detention-Prisoners Board. It was moved by Commissioner Johnston and seconded by Commissioner Wassenberg to adopt Resolution No. 97-539W authorizing the transfer of funds. The motion carried.
