OFFICIAL COUNTY COMMISSIONER PROCEEDINGS
JUNE 9, 1997

The Board of County Commissioners met as the County Board of Equalization on this date at 9:00 a.m. with Buzz Wassenberg, Bill Cramer, Gordon Johnston, Janet Montgomery, County Assessor, and Mary Lankford, County Clerk present.

The Board reviewed the following petition of contested valuation:

1. A. Joseph DeGrazio Trust, Lot 2, Orcutt Hill Subdivision, Unit III. Joe DeGrazio discussed his rising taxes and the inequity of the system. County Assessor Janet Montgomery presented justification for the valuation based on comparable sales. It was moved by Commissioner Cramer and seconded by Commissioner Johnston to deny the petition. The motion carried.

Comments were made by Jerry Tully and George Palmer regarding taxes and assessments. Palmer was referred to the County Assessor.

The Board adjourned as the County Board of Equalization and convened as the Board of County Commissioners to prepare the FY98 budget.

The Board approved an increase in County mileage to \$.28 per mile, per statute, and discussed County facilities and the need for planning for future space needs.
