Commissioner Johnston discussed a complaint from Gary Neely and the transfer station.

Paul Scherbel explained his estimate of \$10,000 for the surveying of Mark Jones road, which would include the centerline, all resolutions and plats, and easements.

Misty Haehn, Planning and Zoning Administrator, and Deputy County Attorney Ed Wood discussed manufactured housing, mobile homes, and modular homes. The Board requested Haehn to prepare information for the Board to study on the matter.

Wood reported that the Golf Course Subdivision annexation should be final by August.

Commissioner Johnston requested that the Recreation Board present plans for self-support for the golf and hockey programs, when the Recreation Board appears before the Board, at its next meeting.

In accordance with the public notice published in the Pinedale Roundup on June 26, 1997, public hearing was held for the transfer of funds in the amount of \$39,271.12 from Unanticipated Revenue: Communications-E911, \$3,864.82, Law Enforcement-Maintenance on Vehicles, \$1,255.21, Law Enforcement-Uniforms, \$12,488.00, Law Enforcement-Criminal Investigation, \$3,509.61, County Commissioners-Special Attorney, \$495.00, Planning & Zoning-Equipment, \$100.00, General Fund-Skyline Drive Plowing, \$1,250.00, General Fund-Historic Survey, \$121.36, General Fund-Ambulance Barn, \$789.47, General Fund-Postage, \$492.25, and Cash Reserve, \$14,905.40. It was moved by Commissioner Cramer and seconded by Commissioner Johnston to adopt Resolution No. 97-546W authorizing the transfer of funds. The motion carried.

The County Clerk was authorized to issue beer permits to parties during the next two weeks, who have previously received permits for local festivities and waived the temporary merchant permit fee for Rendezvous.

The following petition and affidavit of abatement of taxes was presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Riata Energy, Inc., \$65.71, and Chevron USA, Inc., \$16,797.53.

It was moved by Commissioner Johnston and seconded by Commissioner Cramer to re-appoint Jerry Wilson for a three-year term to the Library Board. The motion carried.

It was moved by Commissioner Johnston and seconded by Commissioner Cramer to appoint Peggy Bell for a three-year term to the Planning and Zoning Commission. The motion carried.

It was moved by Commissioner Johnston and seconded by Commissioner Cramer to reappoint Dale Jensen and Robert Thompson for three-year terms to the Museum Board. The motion carried.

It was moved by Commissioner Johnston and seconded by Commissioner Cramer to reappoint Dr. David Burnett for a three-year term to the Joint Big Piney-Marbleton Airport Board. The motion carried.

Appointments to the Fair Board, Recreation Board, and Golf Committee will be made at a future date.

The Board discussed Emergency Management with Scott Thompson and directed him to update his operating plans and reviewed his budget request.

Representative Louie Tomassi expressed his support for the Fair Board and its request for 1/2 mill for a multi-purpose building at the Fairgrounds.

Representative Tomassi requested that the Board consider supporting the use of the Marbleton Clinic for emergency services by Dr. Burnett, for a fee, since he has moved into private practice. The Board supported the request and will write a letter to the Rural Health Care Board.

John Linn, representing himself, presented a prepared statement regarding the Marbleton Clinic and the departure of Dr. David Burnett. Pat Chapel expressed the support of the Big Piney community for Dr. Burnett. Chairman Wassenberg stated his opposition to dissolving the Rural Health Care District, due to the loss of its two mills of tax, and stated that the district cannot continue funding the clinic contracts to the extent that its presently maintains. Linn stated that the Rural Health Care Board has no respect for Dr. Burnett and the community. Representative Tomassi discussed parity. Deputy County Attorney Ed Wood advised the Board about the liability and responsibility of the doctor, who contracts with the District for the use of the clinic, and the need for someone to be "in charge". Commissioner Johnston stated that the District cannot afford to do the will of the people in southern Sublette County.

After Commissioner Cramer requested information about the staffing of the County Court from Judge John Crow, the Board tentatively approved the County Court budget of \$130,751.
