

Dave Simonson of Wyoming Machinery Company, presented lease-purchase documents for a 1997 140H motorgrader with Heinke snow equipment for the amount of \$193,590, with a finance amount of \$103,090, and trade of \$93,500. Interest on the lease is 5.9% with five annual payments of \$23,475.891. The Board signed the documents and will decide with the next 30 days, if it will continue the lease or purchase the equipment outright.

The Board moved the meeting to the Courtroom, due to the number of people present for the discussion of the Mark Jones road. Sixty-six concerned citizens were present. Commissioners Wassenberg and Johnston stated their opposition to the movement of the road. Commissioner Cramer stated his support for moving the road and opposition to adverse possession. At the conclusion of the discussion, the Board directed Paul Scherbel to survey the centerline of the proposed road for the amount not to exceed \$3,500.
