

Thirteen people were present to discuss snowplowing on Beaver Ridge for the upcoming season. Betsy Greenwood, representing some of the residents of the area, requested additional time to review costs and present options to the Board. The Board approved the request and will discuss the issue at the December 16th meeting. The Board directed the County Clerk to notify all area residents, by mail, of the December 16th meeting.

The Board discussed a letter from Dr. Tom Johnston regarding zoning issues, which was referred to the Planning and Zoning Commission for comment. It was noted that a similar letter was received last year concerning the same issues.

Misty Haehn, County Planner, presented the County Zoning Maps, as prepared by Pam Curry from the County GIS system.

The Board recessed into Executive Session to discuss possible litigation and to confer by conference call with Davis and Cannon on the Exxon matter.

The following petition and affidavit for abatements of taxes was presented on petition from the County Assessor and the State Board of Equalization: Larry Thompson, \$281.10.

County Treasurer Nylla Kunard discussed the application of payments from Rod Bennett. It was determined that the 1997 taxes will need to be abated, and that it is possible that the 1998 taxes will not be levied. Ed Wood was directed to notify Bennett by letter of the approval of the extension of the contract for spring construction.

The Elected Officials, Nylla Kunard, Marilyn Jensen, and Mary Lankford, reported on computer software and obtaining more proposals from space consultants.
