OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
JANUARY 20, 1998

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Bill Cramer, Gordon Johnston, Jim Hutchinson, Dave Trombly, Cat Urbigkit of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of January 6, 1998, were ordered filed on motion by Commissioner Cramer and seconded by Commissioner Johnston. The motion carried.

The official bonds for Patrick C. Mattimoe, Secretary Treasurer for the Shelter Park Improvement District, in the amount of \$25,000; and Gail A. Grubb, Treasurer for the Sublette County Golf Committee, in the amount of \$5,000, were approved and ordered filed with the County Treasurer.

It was moved by Commissioner Johnston and seconded by Commissioner Cramer to accept the sealed bids from the following individuals for Road and Bridge equipment and materials:

The motion carried.

The Board questioned the availability of a spare tire for the Fair Board pickup and some gravel for the Fairgrounds. Mike McGinnis, Road and Bridge Superintendent, advised the Board that he would check for a spare tire, and that he is pursuing gravel near the Fairgrounds that would be available.

McGinnis discussed the Peterson Hill project, the landfill cell excavation, installation of power at the landfill, and the possible purchase of scales.

It was moved by Commissioner Johnston and seconded by Commissioner Cramer to adopt Resolution No. 98-564W setting a hearing for the vacation of part of the Pole Creek Stock Driveway County Road No. 23-161 on March 3, 1998, directing the County Clerk to publish the required notice in the Pinedale Roundup for three successive weeks, and further directing the County Clerk to notify by certified mail all persons owning or claiming any interest to any of the lands over or across which said road is proposed to be vacated. The motion carried.

After discussion and consultation with Deputy County Attorney Ed Wood, it was moved by Commissioner Johnston and seconded by Commissioner Cramer to designate the Pinedale Roundup as the official county newspaper for 1998. The motion carried.

The Board approved and signed an expert agreement with William Davis, III, for the Exxon matter.

The Board participated in a conference call with John McKinley of Davis and Cannon regarding opposition to the confirmation of the appointment of Ed Schmidt to the State Board of Equalization. The Board requested information and discussed possible legislation for disclosure.

The Elected Officials, Hank Ruland, Nylla Kunard, Marilyn Jensen, Janet Montgomery, and Department Head Pam Curry discussed Internet access to information. The Board requested that a plan be prepared by May.

Ruland and Undersheriff Henry Schmidt discussed search and rescue, drug arrests, and staffing.
