OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS
MARCH 3, 1998

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Bill Cramer, Gordon Johnston, Dave Trombly, Jim Hutchinson, George Funk, Ed Birckhead, Deputy County Attorney Ed Wood, Cat Urbigkit of the Pinedale Roundup, Mike McGinnis, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of February 17, 1998, were approved and ordered filed on motion by Commissioner Cramer and seconded by Commissioner Johnston. The motion carried.

In accordance with the public notice published on February 5, 12, and 19, 1998, public hearing was held for the vacation of the Pole Creek Stock Driveway County Road No. 23-161. It was noted that no objections were received. It was moved by Commissioner Cramer and seconded by Commissioner Johnston to vacate Pole Creek Stock Driveway County Road No. 23-161, per the public notice. The motion carried.

It was moved by Commissioner Cramer and seconded by Commissioner Johnston to adopt Resolution No. 23-565W authorizing the Chairman of the Board of County Commissioners, attested by the Clerk, to sign an affidavit proffered in the name of the County and the Board for land owned by Sublette County within the Boulder Townsite. The motion carried and Chairman Wassenberg signed the affidavit.

Paul Scherbel discussed the Dean Interpretive Site with the Board. The Board directed Scherbel to prepare a plat of the site.

Keith McNinch presented the plans for the Peterson Hill project. It was moved by Commissioners Cramer and seconded by Commissioner Johnston to approve the plans subject to review by Deputy County Attorney Ed Wood, and upon his approval, proceed with advertisement for bid. The motion carried.

Leo Schueler discussed RS 2477 and public access to public lands. The Board took the matter under advisement.

Sheriff Hank Ruland and Undersheriff Henry Schmidt updated the Board on the Sivak shooting and reported that Deputy Rocky Shaver has been placed on administrative leave. Ruland discussed developing another shooting range at the old Daniel Landfill and reported that Paco Clendennen was back to work.

Mike McGinnis, Road & Bridge Superintendent, discussed power options for the Marbleton Landfill, presented an application for a fire lane at the Landfill, and discussed equipment pricing for road maintenance reports. It was reported that the FAA has been contacted regarding the Big Piney Airport gravel pit.

Bob Reese and Greg Clark, District Rangers, discussed enlargement of the parking areas for winter use at Horse Creek, Upper Green River, and Middle Piney. Reese reported on the Pinedale waterline, oil and gas environmental impact statements, White Pine Ski Area, and the Half Moon Mountain timber sale.

Dana Stone, State Forester, presented the 1998 Wildland Fire Control Annual Operating Plan for approval. It was moved by Commissioner Cramer and seconded by Commissioner Johnston to authorize Chairman Wassenberg to sign the plan. The motion carried and the plan was signed.

Clark Allan, County Attorney, reported on the Sivak shooting and informed the Board that his staff will be provided with mace and firearm training.
