## OFFICIAL COUNTY COMMISSIONERS PROCEEDINGS

APRIL 7, 1998

The Board of County Commissioners met in regular session on this date at 9:00 a.m. with Buzz Wassenberg, Bill Cramer, Gordon Johnston, Dave Trombly, George Funk, Mike McGinnis, Cat Urbigkit of the Pinedale Roundup, Deputy County Attorney Ed Wood, and Mary Lankford, County Clerk present.

The minutes of the preceding meeting of March 17, 1998, were approved and ordered filed on motion by Commissioner Cramer and seconded by Commissioner Johnston. The motion carried.

The minutes of the preceding special executive session of March 24, 1998, were approved and ordered filed on motion by Commissioner Johnston and seconded by Chairman Wassenberg. The motion carried.

Sealed bids were opened for the construction of the Peterson Hill Project on Cottonwood Ryegrass County Road No. 23-117. Six bids were received. After review for completeness by Paul Scherbel and Mike McGinnis, it was moved by Commissioner Cramer and seconded by Commissioner Johnston to award the bid to Schmid Sand and Gravel, Inc. for the amount of \$76,450.00 subject to the execution of a contract and performance bonding. The motion carried.

The Board requested McGinnis consider the removal of a cattleguard on North Piney County Road No. 23-143. McGinnis agreed to review the site.

McGinnis reported that measures were taken to prevent the flooding of the Loos property in Shelter Park. Deputy County Attorney Ed Wood reported that Bob Harrower has indicated that he would consider a letter of agreement with the consent of the ditch owners and other adjacent property owners to resolve the potential for flooding of the Loos property.

The extension of Crear Lane County Road No. 23-213 was reviewed. It was reported that Kyle Brewer is reluctant to give the necessary easement for the extension and that there are other encroachments to the potential easement. The Board decided to not pursue the project and directed McGinnis to report their decision to Russ Hadley.

McGinnis reported on the opening of roads, crushing, the landfill buildings, and repairs to the Daniel Merna County Road No. 23-112.

David and Monta Faye Brown, acting as agents for the Trustees, Richard Weldon and Jerry Luis, of the Rudy Smithers Revocable Trust presented a petition for a private road located in the N1/2SW1/4 of Section 9, T35N, R111W. The Board set the petition for hearing on Tuesday, May 5, 1998, at 9:15 a.m.

Monte Skinner expressed his opposition to developing a parking lot on the County's open space adjacent to the Courthouse. The Board advised Skinner it is not considering a parking lot.

The Board requested Robin Miley to forward a copy of his letter from the FAA regarding crushing gravel at the Big Piney Airport to the County Clerk.

The County Clerk presented a letter from Christopher G. Jensen inquiring about the possible purchase of County property adjacent to Lot 2 of the Fandek Lot Division. Wood advised the Board to readvertise the property for sale, as it had been advertised last year with no interest. The Board directed the County Clerk to make the proper advertisement.
