

The Board met with the Elected Officials and Department Heads, Stella McKinstry, Joanne Garnett, Janet Montgomery, and Mary Lankford. It was reported that Danny Williams is making plans to visit with all departments regarding space needs. Parking, the employees committee upcoming meeting, and ethics legislation was discussed.

County Assessor Janet Montgomery informed the Board about the TY Pickett contract for \$11,000, which provides industrial appraisal for the County. Montgomery reported that she had discussed the Wexpro notice with Davis and Cannon, and it was decided to contact Wexpro by letter and discuss a refund or credit, which will not effect the appeal.

The following petitions and affidavits of abatement of taxes were presented on petition from the County Assessor and the State of Wyoming Board of Equalization: Troy M. & Wendy L. May, \$220.70, and Harold G. and Glenda F. Eversull, \$43.00.

Dave Bell, representing the Recreation Board, presented a request for sponsorship of a TEAL grant application for the Pinedale Pathway. The proposal will provide a path from Shelter Park to Fremont Lake. The application amount would be approximately \$375,000, which is an 80-20 match grant. The matching funds have been included in the Recreation Board's budget request. It was moved by Commissioner Cramer and seconded by Commissioner Johnston to sponsor the TEAL application, without a funding commitment, and directed the County Clerk to make public notice for a hearing to be held on June 8, 1998, in conjunction with the Recreation Board's budget request. The motion carried.

It was moved by Commissioner Johnston and seconded by Commissioner Cramer to not participate in the State of Wyoming Fire Emergency Suppression Account. The motion carried.

It was decided to change the August 18, 1998, meeting to August 20, 1998, due to the Primary Election.
